PDC EXECOM RESOLUTION NO. 02-2022

A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN (SP) OF THE PROVINCE OF BOHOL THE PROGRESSIVE REPORT OF THE POST-ODETTE RECOVERY AND REHABILITATION PROGRAM OF THE PROVINCE OF BOHOL FOR APPROVAL AND SUPPORT

WHEREAS, super typhoon Odette (international name Rai) made landfall in the Province of Bohol on December 16, 2021 that has caused great damaged to all private and public institutions, facilities and properties in all the 47 municipalities and 1 city of the province;

WHEREAS, in the aftermath of the destructive path of TS Odette 111 Boholano deaths were recorded, 2,040 individual persons injured and 271,345 houses damaged (84,774 totally damaged; 186,621 partially damaged);

WHEREAS, the Bohol Provincial Disaster Risk Reduction and Management (DRRM) Framework is compliant with the National Disaster Risk Reduction and Management (DRRM) Council Framework based on the principles of disaster risk reduction and disaster management in addressing the underlying causes of vulnerability, sustainable development, community empowerment, shared responsibilities, good responsive governance, mutual reinforcing partnership and local and customized adoption and adaptation;

WHEREAS, the result of the Rapid Damage Assessment and Needs Assistance (RDANA) from 37 responsive local government units of Bohol showed an estimated damage cost of Php16,382,520.00 that includes estimates for damages in infrastructure facilities, economic structures, development administration institutions, social development establishments, the environment and private properties;

WHEREAS, the Bohol post-Odette Rehabilitation and Recovery Program is a comprehensive plan that focuses on bringing back to normalcy the lives of the local residents, rehabilitate the many destroyed public facilities and re-ignite its economic and social activities guided by the Build Back Better principle of the National Government;

WHEREAS, the progressive report in the Bohol Post-Odette Rehabilitation and Recovery Program proposes an estimated cost of Php 27,892,526.00 for the damages from the 37 responsive LGUs, with the additional 11 reports from the same number of municipalities to be incorporated in the succeeding consolidation/updating of the program;


WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –
