A RESOLUTION FAVORABLY ENDORSING TO THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCE OFFICE-7 AND THE CENTRAL VISAYAS REGIONAL DEVELOPMENT COUNCIL (RDC-7) THE PROPOSED PRIORITY PROGRAMS, PROJECTS and ACTIVITIES (PPAs) OF THE ENVIRONMENTAL MANAGEMENT BUREAU (EMB) OF THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) FOR THE PROVINCE OF BOHOL FOR INCLUSION IN THE CY 2023 BUDGET PROPOSAL OF DENR.

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –


