PDC-EXECOM RESOLUTION NO. 56-2022

A RESOLUTION FAVORABLY ENDORSING THE MALINAO DAM IMPROVEMENT PROJECT (MDIP) OF THE NATIONAL IRRIGATION ADMINISTRATION IN THE PROVINCE OF BOHOL TO THE CENTRAL VISAYAS REGIONAL DEVELOPMENT COUNCIL (RDC)

WHEREAS, the Malinao Dam Improvement Project (MDIP) encompasses five (5) municipalities namely the Pilar, San Miguel, Ubay, Dagohoy and Alicia serving 1,625 target beneficiaries;

WHEREAS, the MDIP that was initially approved by the NEDA-ICC through NEDA Board Resolution No. 1 series 2014 under locally-funded projects has a total project cost of PHP653.749 Million; however, due to the change of scope, extension of the project implementation and increase in the total project cost, NIA was advised to apply for project restructuring;

WHEREAS, the Design and Specification Division of the NIA-Central Office has opted for the use of a rubber weir, instead of concrete, and revised the project cost to PHP1,572.324 Million;

WHEREAS, the main features of the said project will further modify the existing Bath Tub Spillway into Bath Tub with Rubber Gate Weir. The crest elevation is 152.0 meters, the rubber crest weir elevation is 154.0 meters, and the length of the rubber crest is 322.34 meters;

WHEREAS, the construction of the Proposed Auxiliary Spillway has a broad-crest weir elevation of 152.0 meters with a rubber weir crest elevation of 154.0 meters, and the channel shape is trapezoidal;

WHEREAS, the main objective of the project is to double the impounding capacity of the existing dam, thereby, sufficiently providing irrigation water to unserved and underserved areas of the Bohol Integrated Irrigation System. It also aims to provide the desired volume of water for irrigation to other irrigation systems like the Bayongan and Capayas areas.

WHEREFORE, upon proper motion duly seconded, be it resolved by the Body in a meeting duly convened -



to favorably endorse the Malinao Dam Improvement Project (MDIP) of the National Irrigation Administration in the Province of Bohol (NIA-Bohol) to the Central Visayas Regional Development Council (RDC-7).

RESOLVED FURTHER, to furnish copies of the same Resolution to the NIA Regional Office 7, Congressmen of Bohol: Hon. Edgar M. Chatto, 1st District; Hon. Maria Vanessa C. Aumentado, 2nd District; Hon. Kristine Alexie B. Tutor, 3rd District, for their support and follow-up.


