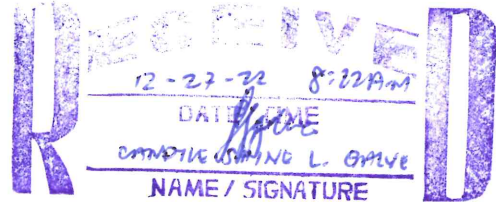

PDC EXECOM RESOLUTION NO. 59-2022

A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN OF BOHOL THE PROPOSAL TO ADD THE SUPPLEMENTAL AMOUNT OF NINETEEN MILLION FOUR HUNDRED THOUSAND PESOS (PHP19,400,000.00) TO THE INVESTMENT PROGRAM OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR CY 2022

WHEREAS, the Provincial Government of Bohol, guided by its development road map and principles of good governance, has identified additional priority initiative for the year 2022, with the issuance of Administrative Orders (AO) No. 3 by the Office of the President, dated December 23, 2022;

WHEREAS, this additional initiative is intended for the Grant of Gratuity Pay to Qualified Contract of Service (COS) and Job Order (JO) Workers of the Provincial Government of Bohol for CY 2022 to recognize their hard work in implementing programs, projects and activities and pivotal role in the delivery of government services amidst the ongoing Covid-19 pandemic and socio-economic challenges, as emphasized in the AO No. 3;

WHEREAS, this additional initiative will require an estimated total amount of Nineteen Million Four Hundred Thousand Pesos (Php19,400,000.00), which correspondingly is the proposed supplemental requirement in the Investment Program (IP) of the Province of Bohol for CY 2022, with the copy of the Supplemental Investment Program (SIP) No. 9 attached hereto and made an integral part hereof;

WHEREAS, the initiative constituting the SIP No. 9 for the year 2022, will correspondingly be treated as supplemental investment items in the current Local Development Investment Plan (LDIP) of the Province of Bohol;

WHEREAS, funding for the initiatives will be obtained from available maintenance and other operating expenses (MOOE) savings under the 2022

Annual Budget, that may be made available thru an Appropriation Ordinance authorizing the Supplemental Budget;

WHEREAS, as provided in the Joint Memorandum Circular No. 01-2007 and JMC No. 1 2016 of the Department of the Interior and Local Government (DILG), National Economic Development Authority (NEDA), Department of Budget and Management (DBM) and the Department of Finance (DOF), as well as the Budget Operations Manual (BOM) of the DBM, local government units (LGUs) are mandated to support all budgets with corresponding investment plans;

WHEREAS, the initiative proposed under the SIP No. 9 for CY 2022, after review and deliberation, has been found by this Body to be in order, aligned with the provincial development thrust of providing allowable incentives and assistance to Provincial Government COS and JO workers and therefore worthy of favorable endorsement to the Sangguniang Panlalawigan for approval;


WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –
