PDC EXECOM RESOLUTION NO. 02-2017

A RESOLUTION APPROVING THE VALUE CHAIN ANALYSIS OF HIGHLAND VEGETABLES IN THE PROVINCE OF BOHOL AS A COMPONENT OF THE CENTRAL VISAYAS VALUE CHAIN ANALYSIS AND FAVORABLY ENDORSING THE SAME TO THE DEPARTMENT OF AGRICULTURE - REGIONAL OFFICE 7 (DA-7) FOR SUPPORT AND EVENTUAL USE AS BASIS IN THE FORMULATION OF THE PROVINCIAL COMMODITY INVESTMENT PLAN (PCIP) OF BOHOL UNDER THE PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP)

WHEREAS, the Province of Bohol is one of the priority areas of the World Bank-funded Philippine Rural Development Project (PRDP) as implemented and managed by the Department of Agriculture;

WHEREAS, PRDP is a six-year project (2013-2019) designed to establish an inclusive and market-oriented agri-fishery sector through strategic investments in priority commodity value chains;

WHEREAS, as one of the initiatives under the PRDP's IPLAN Sub-project Component, a value chain analysis (VCA) is conducted to identify full range of activities, which are required to bring a particular priority commodity into its full value, taking into consideration different phases to include conception, production, and delivery to final consumer;

WHEREAS, in the case of the Province of Bohol, the highland vegetable is one of the priority commodities that are being accorded assistance under the PRDP and accordingly, a VCA has been conducted following the issuance of a No Objection Letter (NOL) by the National Project Coordinating Office (NPCO) last November 15, 2016;

WHEREAS, the value chain approach is used in the preparation of the Provincial Commodity Investment Plan (PCIP) to identify the various actors, their functions, and nature of interfirm relations; understand end-market opportunities that can spur

inclusive growth; identify key constraints to end-market opportunities; formulate interventions to address key constraints and opportunities; identify investment opportunities that will be the basis of the Provincial Commodity Investment Plan (PCIP); and promote collaboration between the national and local governments and the private sector;

WHEREAS, the Highland Vegetable VCA will be used as basis in the preparation of the Provincial Commodity Investment Plan (PCIP), which is a document that identifies priority programs and projects that enhance the productivity and competitiveness of the commodity;

WHEREAS, the PCIP will facilitate the efficient allocation of PRDP and government resources by providing funds to priority interventions on enterprise development, infrastructure and implementation support sub-projects that will be supported by PRDP;

WHEREAS, after review and discussion on the results of the Highland Vegetable Value Chain Analysis, this Body has found it to be relevant, useful and aligned with the development thrust of Bohol on agriculture and food security, and is, therefore, worthy of approval and further endorsement to the Department of Agriculture - PRDP RPCO-7;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened -


to approve the Value Chain Analysis of Highland Vegetable in the Province of Bohol as a Component of the Central Visayas Value Chain Analysis and favorably endorsing the same to the Department of Agriculture - Regional Office 7 (DA-7) for support and eventual use as basis in the formulation of the Provincial Commodity Investment Plan (PCIP) of Bohol under the Philippine Rural Development Project (PRDP);

RESOLVED FURTHER, to furnish a copy of this resolution to all persons and agencies concerned, for information, guidance and appropriate action.


