### PDC-EXECOM RESOLUTION NO. 04 - 2017

**A RESOLUTION FAVORABLY ENDORSING TO THE REGIONAL DEVELOPMENT COUNCIL THE LIST OF PROPOSED PRIORITY PROGRAMS AND PROJECTS (PAPS) OF THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) IN THE PROVINCE OF BOHOL FOR INCLUSION IN THE CY 2018 BUDGET PROPOSAL OF DENR**

**WHEREAS**, the projects are in conformity with the development thrust of the National and Provincial Government in support of Bohol's Overarching Development and National Framework particularly its goals of environment protection and management thru its primary development strategies of enhancing terrestrial and marine biodiversity, integration of National Greening Strategies, resilient and climate smart strategies;

**WHEREAS**, the priority programs of DENR has introduced mechanisms to achieve the objectives such as: a) Development, rehabilitation/maintenance & protection of Forestlands, coastal/marine ecosystems, and biodiversity; b) Payment for Environmental Services (PES) including water regulation, soil conservation, carbon offsets, ecotourism development and biodiversity; c) Land surveys, disposition & records management; d) Management of protected areas and wildlife and habitat); Improve natural resource productivity and; d) Improve climate resilience in the ecosystems;

**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

**To favorably endorse the Proposed Projects of the Department of Environment and Natural Resources in the Province of Bohol for CY 2018 to the Regional Development Council.**
