PDC EXECOM RESOLUTION NO 33-2017

A RESOLUTION FAVORABLY ENDORSING THE CONSTRUCTION OF EVACUATION CENTERS IN THE PROVINCE OF BOHOL TO THE NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (NDRRMC), DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND OTHER RELEVANT INSTITUTIONS FOR SUPPORT AND FUNDING

WHEREAS, the Province of Bohol is an island-province that is highly vulnerable to natural calamities thus making its people susceptible and exposed to natural hazards;

WHEREAS, the Provincial Government of Bohol, as provided for in Provincial Ordinance No 2016-010 which is in compliance to Section 12 of Republic Act No. 10121, "Philippine Disaster Risk Reduction and Management Act of 2010," its Implementing Rules and Regulations (IRR), created the Provincial Disaster Risk Reduction and Management Office whose thrust is to set direction, development implementation and coordination of disaster risk reduction and management program for the entire province;

WHEREAS, the recent natural calamities that occurred in the Province of Bohol showed the necessity to establish evacuation centers that would cater to the needs of those who will be evacuated during calamities for protection and safe sanctuary;

WHEREAS, the PDRMO, thru consultative mechanisms, has identified the establishment of a fully-equipped and disaster-resistant evacuation center in each of the congressional district of the Province of Bohol as one of the strategic mitigating components to lessen the impact of disasters on people in times of man-made and natural calamities and emergencies;

WHEREAS, the establishment of evacuation centers in each of the congressional district in the Province of Bohol would require significant amount of financial resources, which can be raised through counterparting arrangements among local government units, appropriate national government agencies and other concerned stakeholders;

WHEREAS, the establishment of evacuation centers is among the key programs of the Provincial Government, consistent with the spatial development plan of the Province;

WHEREAS, after review and deliberation, the proposed construction of evacuation centers has been found by this Body to be supportive to the attainment of Bohol's development goals and consistent with the spatial development plan of the Province, and therefore worthy of support and endorsement to the National Disaster Risk Reduction Management Council (NDRRMC), Department of Public Works And Highways (DPWH) and other institutions;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –


to favorably endorse the Construction of Evacuation Centers in the Province of Bohol to the National Disaster Risk Reduction and Management Council (NDRRMC), Department of Public Works and Highways (DPWH), and other Relevant Institutions for Support and Funding

RESOLVED FURTHER, to furnish a copy of the same Resolution to the Regional Development Council for support and appropriate action.
