PDC-EXECOM RESOLUTION NO. 46-2017

A RESOLUTION FAVORABLY ENDORSING THE CONDUCT OF FEASIBILITY STUDY AND CONSTRUCTION OF WASTE WATER TREATMENT FACILITY FOR PANGLAO ISLAND, BOHOL TO THE CENTRAL VISAYAS REGIONAL DEVELOPMENT COUNCIL (RDC-7) AND JAPAN INTERNATIONAL COOPERATION AGENCY (JICA) FOR SUPPORT AND FUNDING

WHEREAS, the establishment of Waste Water Treatment Facilities in the province of Bohol is among the priorities identified in the spatial development plan of the province;

WHEREAS, such environmental management infrastructure is necessary in urbanizing areas and high-density tourism zones such as in Panglao Island, and Tagbilaran City considering the volume of waste water generated in these areas brought about by increase in population and socio-economic growth;

WHEREAS, under the Sustainable Environment Protection Project for Panglao (SEPP), studies projected that a total of 16,519 m³ of septage will be generated in Panglao Island by year 2020 and further increase to 19,687 m³ in 2030;

WHEREAS, the initial studies proposed for the establishment of the treatment plant in various potential sites in the municipalities of Dauis and Panglao, within the Panglao Island;

WHEREAS, the estimated cost of investment for the conduct of the detailed feasibility study and actual construction of these kind of facilities require huge amount of resources, which local governments cannot provide due to financial constraints and limitations;

WHEREAS, the project, if realized, will contribute to the sustainable tourism development and overall socio-economic growth of Bohol, with the foreseen benefits of preserving the clear waters and pristine environment of Panglao Island, thus maintaining Bohol's reputation as a prime eco-cultural tourist destination in the country and more importantly protecting the province's biodiversity and rich natural assets;

WHEREAS, after deliberation on the merits of the proposed project, this Body has further recognized the need to expedite the establishment of waste water treatment facilities in the province, taking into account the improving and growing economic activities in Bohol and acknowledged the necessity to source funds and support for the detailed study and actual construction of this project;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened -

To favorably Endorse the Conduct of Feasibility Study and Construction of Waste Water Treatment Facility for Panglao Island, Bohol to the Central Visayas Regional Development Council (RDC-7) and Japan International Cooperation Agency (JICA) for Support and Funding
