PDC-EXECOM RESOLUTION NO. 48 - 2017

A RESOLUTION FAVORABLY ENDORSING THE CONDUCT OF A FEASIBILITY STUDY ON TRAFFIC MANAGEMENT FOR THE STREETS OF TAGBILARAN CITY, BOHOL, PARTICULARLY ALONG J.A. CLARIN STREET FRONTING THE NEW TAGBILARAN CITY HALL AND MAJOR STREETS WITHIN THE AREA TO THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND TO THE REGIONAL DEVELOPMENT COUNCIL OF REGION VII (RDC-7) FOR SUPPORT AND FUNDING

WHEREAS, the traffic situation along the streets of Tagbilaran City, particularly along JA Clarin Streets fronting the new Tagbilaran City Hall and major streets within the area, is very heavy during the rush hours that it has caused great loss of man-hour productivity, reduced business opportunities and poor quality of life of the citizens;

WHEREAS, traffic accidents have been common occurrence along these streets increasing the risks to damage of personal property and even threatens the safety of the riding public;

WHEREAS, the traffic situation is expected to become tremendously heavy due to recent developments in the area like the construction of the new Capitol Complex, expansion of the existing mall and the establishment of new business enterprises;

WHEREAS, any project that will be constructed to manage the traffic situation in the area shall take into consideration the aesthetic, commercial and land use aspects of the area in as much as these will affect the environment of the existing Tagbilaran City Government Center and existing establishments;

WHEREAS, the conduct of a feasibility study by the Department of Public Works and Highways (DPWH) on the best possible ways to manage the traffic situation of the streets along these area will assess the viability of any project that will be established therein where such project will be consistent with and supportive to the development plans of the City and Provincial Government;

WHEREAS, this Body has found said conduct of the Feasibility Study to be in order and necessary to improve the traffic condition of the area, considering the ongoing and future developments of the vicinity, and more importantly to promote public safety and seamless travel for those using these roads;

WHEREAS, this Body recognized the need for technical experts for the conduct of such Feasibility Study, which is estimated to cost P10 Million Pesos. Taking into account the financial and technical requirements, this Body recommends that such proposal be endorsed to appropriate national government agencies for funding support;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened -

To favorably endorse the Conduct of the Feasibility Study on Traffic Management for the Streets of Tagbilaran City, Bohol, particularly along JA Clarin Street fronting the New Tagbilaran City Hall and Major Streets within the Area to the Department of Public Works and Highways (DPWH) and to the Regional Development Council of Region VII (RDC-7) for Support and Funding

RESOLVED FURTHER, to furnish copies of the same Resolution to the DPWH Regional Office and to Hon. Rene L. Relampagos, Representative of the 1st Congressional District of Bohol for support.
