PDC EXECOM RESOLUTION NO. 56-2017

A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN OF BOHOL THE PROPOSAL TO ADD THE SUPPLEMENTAL AMOUNT OF ONE HUNDRED FORTY NINE MILLION FOUR HUNDRED TWENTY THOUSAND PESOS (#149,420,000.00) TO THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR CY 2017

WHEREAS, the Provincial Government of Bohol, guided by its Vision and Mission, overarching In.S.P.I.R.E.D H.E.A.T. I.T. Bohol development agenda has identified additional priority projects and initiatives for CY 2017;

WHEREAS, these proposed priority projects are expected to improve government facilities, enhance responsiveness, and operational efficiency of government services, increase local revenues, and promote better connectivity and safe travel of constituents;

WHEREAS, these additional projects, which will require a total amount of One Hundred Forty Nine Million Four Hundred Twenty Thousand Pesos (₱149,420,000.00), are proposed as supplemental projects to be covered in the Annual Investment Program (AIP) of the Province of Bohol for CY 2017;

WHEREAS, funding for these projects may be obtained from resources of the Provincial Government coming from accumulated surplus and unexpended balances from prior years appropriations, and other local and external sources that may be used for such purposes through Supplemental Budget and Appropriation Ordinance as may be approved by the Sangguniang Panlalawigan;

WHEREAS, as provided in the Joint Memorandum Circular No. 01-2007 of the Department of the Interior and Local Government (DILG), National Economic Development Authority (NEDA), Department of Budget and Management (DBM) and the Department of Finance (DOF), as well as the Updated Budget Operations Manual (UBOM) of the DBM, local government units (LGUs) are mandated to support all supplemental budgets with corresponding AIPs;

WHEREAS, in compliance with said JMC 01-2007, the UBOM, and the applicable provisions of the Local Government Code (R.A. 7160), and as directed by the National Government, a list of the PPAs has been presented to this Body, collectively proposed as the Supplemental AIP No. 1 of the Provincial Government of Bohol for CY 2017, the copy of which is attached hereto and made an integral part hereof, in the total amount aforestated;

WHEREAS, these proposed projects that are covered under this Supplemental AIP for CY 2017, after review and deliberation, have been found by this Body to be in order, aligned with provincial priorities and supportive to the overall development thrusts of Bohol, and therefore worthy of endorsement for approval by the Sangguniang Panlalawigan;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

to favorably endorse to the Sangguniang Panlalawigan of Bohol the Proposal to Add the Supplemental Amount of One Hundred Forty Nine Million Four Hundred Twenty Thousand Pesos (¥149,420,000.00), to the Annual Investment Program (AIP) of the Provincial Government of Bohol for CY 2017
