PDC EXECOM RESOLUTION NO. 61-2017

A RESOLUTION FAVORABLY ENDORSING THE PROPOSED SEAPORT DEVELOPMENT PROJECT IN THE MUNICIPALITY OF DAUIS, BOHOL UNDER PUBLIC-PRIVATE PARTNERSHIP SCHEME, TO THE PHILIPPINE PORTS AUTHORITY (PPA) AND THE REGIONAL DEVELOPMENT COUNCIL OF REGION VII (RDC-7) FOR SUPPORT AND FUNDING FOR THE CONDUCT OF FEASIBILITY STUDY

WHEREAS, there is an existing docking area in Purok II, Barangay Tabalong, Municipality of Dauis, Bohol, catering to sea and fishing vessels:

WHEREAS, such docking area has not been fully utilized due to its depreciated state and absence of proper infrastructure that hinder the development of its potential;

WHEREAS, the Municipality of Dauis, which is located in the Island of Panglao, has continue to progress through its tourism industry, business, fishery and commercial development;

WHEREAS, considering the said docking area's strategic location, an integrated Seaport Development is proposed for it to be developed into a fishermen, commercial and tourism port, directly supporting the economic drivers of the municipality and expanding opportunities for local economic development;

WHEREAS, the docking facility, if developed, can also be used as an important infrastructure support to facilitate and provide the logistical requirements for the development of Dauis and the whole of Panglao Island, especially with the operation of the New Bohol Airport, and potential for the docking of fast crafts, yachts, and tour sea vessels;

WHEREAS, the Integrated Seaport Development is supported by the Barangay of Tabalong and the Municipal Government of Dauis and is proposed for implementation through Public-Private Partnership (PPP) scheme:

WHEREAS, there is a need for proper study to establish further the technical, financial, social, economic and environmental viability of the propose development;

WHEREAS, this Body, after being briefed on the salient features of the project and deliberation among its members, has found the project to be supportive to the development thrust, particularly in the development of infrastructure, tourism and equitable economic opportunities;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

To Favorably Endorse the Proposed Seaport Development Project in the Municipality of Dauis, Bohol under Public-Private Partnership Scheme to the Philippine Ports Authority (PPA) and the Regional Development Council of Region VII (RDC-7) For Support and Funding for the Conduct of Feasibility Study
