### PDC EXECOM RESOLUTION NO. 63-A-2017

**A RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO RENAME THE PROPOSED BRIDGE LINKING PANGLAO ISLAND AND TAGBILARAN CITY UNDER THE DPWH BRIDGE CONSTRUCTION ACCELERATION PROJECT TO TAGBILARAN CITY-DAUIS (PANGLAO ISLAND) BRIDGE**

**WHEREAS**, the Department of Public Works and Highways (DPWH) has proposed for the construction of an iconic bridge linking Tagbilaran City and Panglao Island under the Austrian-assisted DPWH Bridge Construction Acceleration Project;

**WHEREAS**, the DPWH has proposed to name the bridge the Panglao-Tagbilaran City Bridge, which directly connects Tagbilaran City to the Municipality of Dauis, one of the municipalities in the island of Panglao;

**WHEREAS**, it is but proper and appropriate to recognize the Municipality of Dauis as the direct area where the other end of the bridge will be located by including it in the name of the proposed bridge;

**WHEREAS**, this Body, after deliberation, has come into agreement to request the DPWH to rename the bridge as the Tagbilaran City-Dauis (Panglao Island) Bridge, to clearly define where the bridge is actually located and at the same time promote and recognize both Tagbilaran City and Municipality of Dauis through the iconic bridge, once constructed and utilized;


**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –


