PDC EXECOM RESOLUTION NO. 66-2017

A RESOLUTION FAVORABLY ENDORSING THE UPGRADING OF THE RIVERSIDE BRIDGE CONNECTING BARANGAY TOTOLAN TO BARANGAY SONGCULAN, DAUIS, BOHOL TO THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND TO THE REGIONAL DEVELOPMENT COUNCIL OF REGION VII (RDC-7) FOR SUPPORT AND FUNDING

WHEREAS, the 41.15-linear meter steel modular Riverside Bridge in the Municipality of Dauis, Bohol, is the lone access bridge that connects some parts of barangays Totolan and Songculan of the said municipality;

WHEREAS, this bridge, which is used to be a timber type bridge, was upgraded to a steel modular bridge by the National Government being part of the Circumferential Road network of Panglao Island;

WHEREAS, due to its regular utilization, natural wear and tear, and exposure to the weather, the said bridge in a state that imposes danger to lives and properties of the community and thus needs to be upgraded to ensure safety of the traveling public;

WHEREAS, considering further the bridge's strategic location, there is a need to upgrade its load capacity and enhance its design including its elevation from the sea level to improve connectivity and maximize the use of the body of water within the area to support tourism development;

WHEREAS, this Riverside Bridge is part of the road section that may connect to the proposed Tagbilaran-Panglao Island Connector Bridge and may provide the needed access for the construction and maintenance of said Connector Bridge;

WHEREAS, the proposed upgrading of the Riverside Bridge will facilitate the movement of people, goods, and services and will eventually redound to positive socio-economic impact to the locality and to the entire province in general,

WHEREAS, this Body, after discussion and deliberation, has found said infrastructure project to be in order and fully supportive of the development thrusts Provincial Government of Bohol as established in the Provincial Development and Physical Framework Plan particularly improving transport interconnectivity and accessibility for the benefit of the commuting public;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened -

to favorably endorse the Upgrading of the Riverside Bridge Connecting Barangay Totolan to Barangay Songculan, Dauis, Bohol to the Department of Public Works and Highways (DPWH) and to the Regional Development Council of Region VII (RDC-7) for Support and Funding

RESOLVED FURTHER, to furnish copies of the same Resolution to the DPWH Regional and District Offices, and to Hon. Rene L. Relampagos, Representative of the 1st Congressional District of Bohol for support.
