PDC FULL COUNCIL RESOLUTION NO. 03- 2017

A RESOLUTION ADOPTING A PROVINCIAL REVIEW AND INTEGRATIVE MECHANISM REQUIRING THE DIFFERENT LOCAL GOVERNMENT UNITS IN THE PROVINCE OF BOHOL TO SUBMIT THEIR PROPOSED MAJOR PROGRAMS AND PROJECTS AND THEIR COMPREHENSIVE DEVELOPMENT PLANS TO THE PROVINCIAL DEVELOPMENT COUNCIL (PDC) FOR REVIEW, INTEGRATION AND ENDORSEMENT

WHEREAS, under Section 106 of the Local Government Code (LGC), each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council;

WHEREAS, Section 109 of the LGC mandates local development councils to, among others, formulate long-term, medium term, and annual socio-economic development plans and policies, and appraise and prioritize socio-economic development programs and projects;

WHEREAS, Section 114 of the LGC establishes that approved local development plans of LGUs may be integrated with the development plans of the next higher local development council;

WHEREAS, Section 459 of the LGC mandates the Province, as a political and corporate unit of government, services as a dynamic mechanism for developmental process and effective governance of local government units within its territorial jurisdiction;

WHEREAS, the Provincial Government of Bohol has already adopted its Provincial Development and Physical Framework Plan (PDPFP) which guides the development of the province for the next 12 years;

WHEREAS, the Provincial Government of Bohol has updated its overarching development framework, emphasized through its **InSPIRED HEAT-IT Bohol Development Agenda**, setting the priorities and thrusts across development sectors;

WHEREAS, in order to ensure that programs and projects of local government units are aligned with the development framework, principles and priorities of the Provincial Government, it imperative that the following proposed projects be submitted to the Provincial Development Council for its review, integration and endorsement: major programs proposed for funding from the national government agencies, major infrastructure and economic development projects proposed to be funded by the private sector through Public-Private Partnership (PPP) arrangements, programs and projects with significant socio-economic and environmental impact to the province;

WHEREAS, Memorandum Circular No. 2016-102 of the Department of the Interior and Local Government (DILG) enjoins the Provincial Governments to take a pro-active role in the review of local development plans by establishing a review and feedback mechanism through their Provincial Development Councils;

WHEREAS, to implement this mechanism, the Provincial Development Council may tap its Sectoral Technical Working Groups, to provide technical guidance for the review, assessment, integration and recommendation for endorsement;

WHEREAS, these review mechanism will ensure vertical alignment of plans between provincial, city and municipal governments, facilitate the review and endorsement processes especially for proposed programs that need approval and endorsement to the Regional Development Council (RDC), National Economic Development Authority (NEDA) and appropriate national government agencies, promote complementation of programs and collaboration among local government units, enforce protection and sound management of the environment, and provide synchronization and harmonization of the projects from planning, implementation, monitoring and evaluation;


WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

To adopt a Provincial Review and Integrative Mechanism requiring the different Local Government Units in the Province of Bohol to submit their proposed major programs and projects and their Comprehensive Development Plans to the Provincial Development Council for review, integration and endorsement


