PDC EXECOM RESOLUTION NO. 15-2018

A RESOLUTION REQUESTING FOR THE DONATION OF 500 SQUARE METER (SQ. M.) LOT FROM EACH OF THE LOCAL GOVERNMENT UNITS (LGUs) OF PANGLAO, JAGNA, UBAY, TALIBON, TUBIGON, GETAFE, LOAY, AND ANDA TO BE USED AS SITES FOR SUB-STATIONS OF THE PHILIPPINE COAST GUARD (PCG)

WHEREAS, the island-province of Bohol, being one of the many islands of the Philippine archipelago, is surrounded by the sea and many islets;

WHEREAS, protecting and safeguarding the inhabitants and environment of these islands is one of the functions and responsibilities of the Philippine Coast Guard (PCG), as mandated by existing laws and regulations of the Republic;

WHEREAS, the PCG, in order to fully perform its mandates and effectively discharge its various functions, needs to establish stations and sub-stations in strategic locations of Bohol, considering the current status and number of existing sub-stations in the island province;

WHEREAS, the PCG stations and sub-stations in the Province of Bohol are in dire state of dilapidation, which were mostly damaged from the Great Bohol Earthquake of 2013.

WHEREAS, funds are available from the Philippine Coast Guard for the construction of steadier, disaster-resilient and suitable buildings that will facilitate the discharge of its mandates;

WHEREAS, the PCG sub-stations located in the municipalities of Panglao, Jagna, Ubay, Talibon, Tubigon, Getafe, Loay, and Anda have to be located on better-situated area, enough for the substation to be equipped with the necessary personnel, logistics, and equipment needed to cope with its supervisory, emergency-response, law-implementation functions;

WHEREAS, the land requirement for each sub-station, which is estimated at 500 sq. meters, will have to be provided by the respective local government units to the PCG through donation in order to facilitate and initiate such construction of physical structures;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

To request for Donation of 500 Square Meter (Sq. M.) Lot from each of the Local Government Units (LGUs) of Panglao, Jagna, Ubay, Talibon, Tubigon, Getafe, Loay, and Anda to be used as sites for Sub-Stations of the Philippine Coast Guard (PCG)

RESOLVED FURTHER, to furnish a copy of the same Resolution to the PCG Region VII Office and the Local Government of Panglao, Jagna, Ubay, Talibon, Tubigon, Getafe, Loay and Anda for their support and favorable action.
