PDC EXECOM RESOLUTION NO.35-2018

A RESOLUTION FAVORABLY ENDORSING THE PROPOSED BY-PASS ROAD LINKING CALCETA STREET AND HANGOS ROAD IN TAGBILARAN CITY TO THE REGIONAL DEVELOPMENT COUNCIL OF CENTRAL VISAYAS (RDC-VII) AND THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) FOR SUPPORT AND FUNDING

WHEREAS, the Calceta Street and Hangos Road are existing city roads in Tagbilaran City, which are located parallel to each other with both roads linking the J.A. Clarin Street, which is a national road;

WHEREAS, the Calceta Street and Hangos Road are among the city roads that have greater importance considering that they provide direct access to the government center of the City Government, the New Provincial Capitol Building, national government agencies, and economic centers;

WHEREAS, both roads are currently being improved and upgraded to increase and expand capacities as well as provide better travel accessibility and convenience to the riding public;

WHEREAS, taking into consideration the increasing traffic volume at J.A. Clarin Street and the expected surge of traffic flow at the Calceta Street and Hangos Road with the completion and operation of the New Provincial Capitol Building and establishment of new business enterprises in the area, there is a need to open and construct a by-pass road to link Calceta Street and Hangos Road, parallel to the J.A. Clarin Street;

WHEREAS, the Provincial Government of Bohol is committed to acquire the needed land for the road right of way for the said road project, which is proposed to be located further back of the Tagbilaran City Hall and the Bohol Agricultural Promotion Center;

WHEREAS, the proposed by-pass road has an estimated total road length of 600 meters with an estimated cost of P36.0 Million for its opening and construction;

WHEREAS, opening the said by-pass road to link the two existing city roads that connects to the J.A. Clarin national road provides better alternative to travelling public and will help ease the traffic situation in these areas through better and safe road connectivity while improving travelling time and convenience;

WHEREAS, taking into account the limited funds of the City Government as well as the Provincial Government, it would be best to request fund assistance from the Department of Public Works and Highways (DPWH) through the department's By-Pass Road Program to ensure the implementation of the said priority road project;

WHEREAS, this Body has found the said project to be in order and fully-supportive of the development thrusts and strategies of government, particularly in accelerating infrastructure development, and expanding and increasing access to economic opportunities;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

To favorably endorse the Proposed By-Pass Road linking Calceta Street and Hangos Road in Tagbilaran City to the Regional Development Council of Central Visayas (RDC-VII) and Department of Public Works and Highways (DPWH) for Support and Funding


