PDC EXECOM RESOLUTION NO.36-2018

A RESOLUTION FAVORABLY ENDORSING THE PROPOSED BY-PASS ROAD FROM SAN ISIDRO – CABAWAN, TAGBILARAN CITY TO MALAYO NORTE, MUNICIPALITY OF CORTES, BOHOL TO THE REGIONAL DEVELOPMENT COUNCIL OF CENTRAL VISAYAS (RDC-VII) AND THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) FOR SUPPORT AND FUNDING

WHEREAS, the Provincial Government of Bohol has started to develop its parcel of land located in Malayo Norte, Municipality of Cortes, consistent with its development framework to establish an integrated development in the area for governance, medical and wellness zone;

WHEREAS, the site is the location of the new Municipal Hall of Cortes and the soon to be constructed Bohol Youth Home – the rehabilitation center for juvenile, and other major facilities such as the Bohol Drug Abuse Treatment and Rehabilitation Center, and the Gov. Celestino Gallares Medical Center;

WHEREAS, current access to the said integrated area development is limited to a national road that links Cortes to Tagbilaran and the Municipality of Balilihan;

WHEREAS, there is a need to develop an alternate route going to said site considering the foreseen increase in traffic volume in the existing national road, and the necessity for a shorter route and travel time from Tagbilaran City and nearby municipalities;

WHEREAS, there are existing local roads that connect barangay San Isidro – Cabawan, Tagbilaran City to Malayo Norte, Cortes, which can be

improved and upgraded to function as by-pass road to provide the public direct access to the facilities and to the Municipality of Cortes, in general;

WHEREAS, these local road sections are currently maintained by the local government units of Cortes and City of Tagbilaran, with some assistance from the Provincial Government of Bohol in certain areas;

WHEREAS, the improvement and upgrading of the road section that will comprise the by-pass road is expected to cover approximately 9.10 kilometers with an estimated cost of P273.0 Million;

WHEREAS, with due consideration of the funding requirements and the limited funds of the municipal, city and provincial governments, it is necessary that funding assistance be requested from the national government, particularly the Department of Public Works and Highways (DPWH);

WHEREAS, this Body, after deliberation, has found said project to be in order and supportive of the development thrusts of the local and national governments, particularly in improving access to social services by providing better road connectivity;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

To favorably Endorse the Proposed By-Pass Road from San Isidro – Cabawan, Tagbilaran City to Malayo Norte, Municipality of Cortes, Bohol to the Regional Development Council of Central Visayas (RDC-VII) and the of Public Works and Highways (DPWH) for Support and Funding


