PDC EXECOM RESOLUTION NO.39-2018

A RESOLUTION FAVORABLY ENDORSING TO THE CENTRAL VISAYAS REGIONAL DEVELOPMENT COUNCIL (RDC-7) AND THE DEPARTMENT OF TRANSPORTATION (DOTR) THE PROPOSED ADDITIONAL WORKS FOR THE NEW BOHOL AIRPORT CONSTRUCTION AND SUSTAINABLE ENVIRONMENT PROTECTION PROJECT (NBACSEPP) FOR SUPPORT AND FUNDING

WHEREAS, current trend of air travel shows the number of passengers travelling through local airports in the country has rapidly increased due to available promotional fares offered by airline companies, the uptrend development of tourism industry that entices people to travel, and the limited options for land and sea travel within the archipelago;

WHEREAS, with the limited runway capacity of the Ninoy Aquino International Airport (NAIA), slot to cope with further increase in flight operations is no longer available and that national flag carriers are considering to cater for international flight operations directly through local airports of destinations;

WHEREAS, owing to the vast tourism resources and world-class resorts available in the Province of Bohol, it has been projected that, with the completion and operation of the New Bohol Panglao International Airport in the third quarter of 2018, tourist arrivals in the province will exponentially increase, and that more domestic and international flights will ply to the Panglao, Bohol route;

WHEREAS, by 2020 to 2030, with the expected tourism potentials in Bohol, increase in international flights is forecasted, including long-haul flights to new destinations in Asia, Europe, and North America, through stop overs in appropriate areas;

WHEREAS, as a result of these forecasts, there is a need to consider in advance the additional works that need to be undertaken to ensure that the capacities and facilities of the New Bohol Panglao International Airport are appropriately provided in time to accommodate the significant increase in flights, passenger traffic, cargoes, and expanded air travel opportunities to Bohol, taking into account the gestation period and approval process of infrastructure projects of this magnitude;

WHEREAS, with the updated study and analysis, additional works for the New Bohol Airport Construction and Sustainable Environment Protection Project (NBACSEPP) is requested, to include, among other components, the 300-meter runway extension, the construction of cargo terminal, fuel depot and hydrant system, and parallel taxiway, which is estimated to cost P 1.966 Billion:

WHEREAS, after being briefed on the underlying justification and salient components of the additional works for the new airport, this Body has found the proposal to be necessary and timely to ensure that facilities can cope with the significant growing demand for air travel services in the near future;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

To Favorably Endorse to the Central Visayas Regional Development Council (RDC-7) and the Department of Transportation (DOTr) the Proposed Additional Works for the New Bohol Airport Construction and Sustainable Environment Protection Project (NBACSEPP) for Support and Funding

RESOLVED FURTHER, to furnish a copy of the same Resolution to the DOTr and NEDA Central Office for support and appropriate action.
