### **PDC EXECOM RESOLUTION NO. 45-2018**

**A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN THE PROPOSED RE-ALIGNMENT OF THE TOTAL AMOUNT OF TWO MILLION FOUR HUNDRED TWO THOUSAND NINE HUNDRED FIFTY-FIVE PESOS (₱ 2,402,955.00) FOR THE PURCHASE OF MEDICAL EQUIPMENT TO BE USED AT THE CATIGBIAN DISTRICT HOSPITAL, PROVINCE OF BOHOL**

**WHEREAS**, the Provincial Government of Bohol (PGBh) owns and operates ten (10) hospital and health facilities through the island-province with the purpose of providing acute and convalescent health and medical/surgical/obstetric-gynecologic care to its constituents;

**WHEREAS**, the Catigbian District Hospital is one of these health facilities being operated by the Provincial Government of Bohol (PGBh), which is located at the Municipality of Catigbian, Province of Bohol, and is duly licensed by the Department of Health (DOH) as a Primary Care Facility;

**WHEREAS**, the Provincial Government of Bohol (PGBh) and the management of the Catigbian District Hospital aim to upgrade the DOH accreditation of the said hospital into Level I Health Facility in order to provide more services to its clientele;

**WHEREAS**, the Provincial Government of Bohol (PGBh) appropriated the total amount of Two Million Four Hundred Two Thousand Nine Hundred Fifty-Five Pesos in CY 2016, under the 20% Development Fund, for the purchase of two (2) Light Emitting Diode (LED) type Lamp for the Operating Room and Delivery Room at the Catigbian District Hospital;

**WHEREAS**, the Provincial Government of Bohol (PGBh) was not able to purchase the two (2) items because the Department of Health purchased and provided the said items to the Catigbian District Hospital, as part of its regular assistance to the Local Government Units (LGUs);

**WHEREAS**, the Department of Health (DOH), during its annual evaluation and inspection of Catigbian District Hospital, recommended for the purchase of equipment that are requirements for its upgrading into Level I Health Facility;

**WHEREAS**, the Management of the Catigbian District Hospital has agreed to propose the purchase of equipment needed for the accreditation of the hospital as a Level I Health Facility and to request the Provincial Government of Bohol through the Sangguniang Panlalawigan to re-align the unused CY 2016 appropriated amount for the purchase of these equipment.


**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

**to favorably endorse to the Sangguniang Panlalawigan the proposed Re-Alignment of the Total amount of Two Million Four Hundred Two Thousand Nine Hundred Fifty-Five Pesos (₱ 2,402,955.00) for the purchase of Medical Equipment to be used at the Catigbian District Hospital.**


