#### **PDC EXECOM RESOLUTION NO. 46-2018**

**A RESOLUTION FAVORABLY ENDORSING TO THE REGIONAL DEVELOPMENT COUNCIL REGION VII (RDC-7) THE REQUEST FOR FUNDING ASSISTANCE TO THE JAPAN INTERNATIONAL COOPERATION AGENCY (JICA) AND OTHER FUNDING AGENCIES FOR THE PREPARATION OF A FEASIBILITY STUDY/MASTER PLAN FOR THE PROPOSED NORTHEASTERN CORRIDOR DEVELOPMENT PLAN OF THE PROVINCE OF BOHOL**

**WHEREAS**, the Local Government Code (LGC) of 1991 (RA 7160), with the aid of various plans, expects every Local Government Unit to more effectively manage their own local development through coordinated planning and programming of various socio-economic and infrastructure activities. Section 20 of the LGC mandates LGUs to prepare a comprehensive land use plan (CLUP) enacted through a zoning ordinance, while Sections 106 and 109 of the same Code mandate the LGUs to prepare comprehensive multi-sectoral development plans (CDP) and public investment programs;

**WHEREAS**, the Provincial Government of Bohol, through a series of participatory planning activities and workshops, has set the development directions of the Province of Bohol that are clearly defined in the Provincial Development Physical Framework Plan (PDPFP) 2016-2028, a multi-year development plan that was endorsed by the Provincial Development Council through PDC Full Council Resolution No. 01-2016 on December 21, 2016 and duly approved by the Sangguniang Panlalawigan through Resolution No. 2017-113 on February 03, 2017;

**WHEREAS**, the Provincial Government of Bohol (PGBh) has identified the northeastern corridor of the Province of Bohol as a potential development area in the aspect of agri/agra-culture, light industry, eco-culture, housing and economic enterprise and commerce;

**WHEREAS**, a comprehensive and coordinated development will be one of the potential and primary outcomes that a Feasibility Study or Master Plan will bring, with emphasis on environmental protection and sustainable utilization of resources;

**WHEREAS**, the proposed Northeastern Growth Corridor of the Province of Bohol will include the areas covered under the Carood Watershed Protected Area and specifically includes the municipalities Alicia, Ubay, Trinidad, Dagohoy, Danao, Inabanga and Getafe;

**WHEREAS**, the structured and planned development of this corridor of the Province of Bohol will help decongest the exponential development in the fast urbanizing southern corridor of Tagbilaran City and the municipalities of Davis and Panglao because of the recently opened new Bohol-Panglao International Airport (BPIA), which will re-distribute the growth throughout the entire Province, thus providing more economic and commercial development in the countryside and further reducing poverty incidence;

**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

**to favorably endorse to the Regional Development Council Region VII (RDC-7) the request for Funding Assistance to the Japan International Cooperation Agency (JICA) and other Funding Agencies for the Preparation of a Feasibility Study/Master Plan for the Proposed Northeastern Corridor Development Plan of the Province of Bohol.**


