PDC FULL COUNCIL RESOLUTION NO.01-2018

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF TRANSPORTATION (DoTr) TO NAME THE NEW BOHOL AIRPORT IN PANGLAO ISLAND AS THE BOHOL-PANGLAO INTERNATIONAL AIRPORT

WHEREAS, the new airport in Panglao Island in the Province of Bohol is expected to be completed and operated in 2018 with the ongoing construction of the airport through the New Bohol Airport Construction and Sustainable Environmental Protection Project (NBACSEPP);

WHEREAS, the NBACSEPP is among the priority infrastructure development programs of the government and is funded through the Japan International Cooperation Agency (JICA) and the Philippine Government, as supported by the Provincial Government of Bohol and other concerned local governments in the Province;

WHEREAS, the completion and operation of the new airport will further boost the socio-economic development of Bohol with the expected exponential increase in tourists and establishment of favorable business environment owing to the better facilities for air travel to and from the province;

WHEREAS, the new airport will be an iconic infrastructure landmark in Bohol due to its modern, spacious, environmental-friendly and green architectural design, which depict the common aspiration of Boholanos;

WHEREAS, the airport, being the only gateway for air travel in Bohol, should be appropriately named to further promote the province as an eco-cultural tourism destination to local and international visitors and travelers;

WHEREAS, it is proposed to call the new airport in Panglao Island as the **Bohol-Panglao International Airport** to distinctively include both Bohol Province and Panglao in the name for better identification and retention of the said airport to the general public;

WHEREAS, after due discussion, this Body has found the proposed name as proper and worthy of approval and endorsement to the Department of Transportation (DoTr) for support and adaption;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

to earnestly request the Department of Transportation (DoTr) to name the new Bohol airport in Panglao Island as the Bohol-Panglao International Airport

RESOLVED FURTHER, to provide copies of this resolution to the Sangguniang Panlalawigan of Bohol for the august Body's support and passage of separate legislative measure relative to this matter, and to the National Economic Development Authority (NEDA), Japan International Cooperation Agency, and other agencies concerned for consideration and support.
