## PDC EXECOM RESOLUTION NO 39-2020

A RESOLUTION FAVORABLY ENDORSING TO THE REGIONAL DEVELOPMENT COUNCIL OF REGION VII (RDC-7) THE PROPOSAL FOR THE BOHOL INTEGRATED AREA DEVELOPMENT MASTER PLAN, PHASE II, FOR FURTHER ENDORSEMENT TO THE JAPAN INTERNATIONAL COOPERATION AGENCY (JICA) FOR FUNDING

**WHEREAS**, the Province of Bohol is a strong advocate of economic growth through sustainable development, where the achievement of economic growth is coupled with protection of the natural/biological resources and its diversity, vital ecosystem functions, and overall environmental quality;

**WHEREAS**, the Province of Bohol was a recipient of the Master Plan Study of the Bohol Integrated Area Development (BIAD), a grant from the Government of Japan, which was conducted by the Japan International Cooperation Agency (JICA) last February 1980;

**WHEREAS**, the Bohol Integrated Area Development (BIAD) Master Plan provided the Province of Bohol with a comprehensive and coordinated development plan that utilized its natural and human resources in a judicious and sustainable manner;

**WHEREAS**, the most tangible outcome of this well-planned development in Bohol is its graduation from being one of the poorest provinces in the country and the upliftment of the living conditions of its constituents through improved socioeconomic conditions and enahnced public service;

**WHEREAS**, the next phase for Bohol to sustain its development trajectory requires another comprehensive and integrated master plan that will encompass the various plans, program and projects that are generated from all stakeholders, with inclusivity and sustainability;

**WHEREAS**, this Body has discussed the merits of the proposal, and found it worthy of favorable endorsement to the Regional Development Council of Region VII (RDC-7) and, subsequently, to other agencies that may be able to assist in the conduct of a master plan therefor;

**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened —

to favorably endorse to the Regional Development Council of Region VII (RDC-7) the Proposal for the Bohol Integrated Area Development Master Plan, Phase II, for further endorsement to the Japan International Cooperation Agency (JICA) for funding.
