PDC EXECOM RESOLUTION NO. 42-2020

A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN OF BOHOL THE PROPOSAL TO ADD THE SUPPLEMENTAL AMOUNT OF ONE BILLION FOUR HUNDRED THIRTY-SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (P1,437,500,000.00) TO THE INVESTMENT PROGRAM OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR CY 2020

WHEREAS, the Provincial Government of Bohol, guided by its development priorities as well as the necessities to respond to the current COVID-19 public health concern, has identified additional priority programs, projects and activities (PPAs) for the year 2020;

WHEREAS, these PPAs are meant to improve roads to promote socio-economic development and peace in rural areas, build the capacity of the Province to detect and prevent the spread of COVID-19, improve hospital facilities, provide the appropriate and allowable pay for hospital workers and allowance to public health workers under this COVID-19 community guarantine;

WHEREAS, these additional PPAs will require an estimated total amount of One Billion Four Hundred Thirty-Seven Million Five Hundred Thousand Pesos (P1,437,500,000.00), which correspondingly is the proposed supplemental requirement in the Investment Program (IP) of the Province of Bohol for CY 2020, with the general details below and with the SIP Form attached made an integral part hereof;

WHEREAS, these PPAs, as part of the SIP No. 5 for the year 2020, will correspondingly be included as supplemental investment items in the current Local Development Investment Plan (LDIP) of the Province of Bohol;

WHEREAS, funding for these PPAs may be obtained from resources within the Provincial Government such as savings and balances from current appropriation which remain free of any obligation or encumbrances, external sources such as the Local Government Support Fund (LGSF) for 2020 per LBC No. 122, loan proceeds from government financial institutions, and other support funds from the national government and development partners;

WHEREAS, Joint Memorandum Circular No. 02 of the DILG and DBM dated March 30, 2020, set provisional guidelines on the preparation and approval of the investment programs of LGUs in view of the Covid-19 situation, providing greater flexibility for LGUs to enable them to adequately and effectively respond to the crisis in a timely manner;

WHEREAS, this Executive Committee of the Provincial Development Council of Bohol, taking into consideration the urgency of the matter, the physical distancing requirement to avoid possible risks related to the Covid-19 situation, has decided to act on the need to endorse the above PPAs through a referendum, in lieu of the physical meeting of the Execom members;

WHEREAS, the PPAs under the proposed SIP No. 5 for CY 2020, after review, has been found by this Body to be in order and responsive to improve accessibility in hinterland barangays, strengthen our capability to manage the COVID-19 health concern in the new normal situation, and promote better health services in our provincial hospitals;

WHEREFORE, upon proper conduct of the referendum, be it resolved by this Body-

to favorably endorse to the Sangguniang Panlalawigan of Bohol the proposal to add the supplemental amount of One Billion Four Hundred Thirty-Seven Million Five Hundred Thousand Pesos (P1,437,500,000.00) to the Investment Program of the Provincial Government of Bohol for CY 2020
