#### PDC-EXECOM RESOLUTION NO. 49 - 2020

A RESOLUTION FAVORABLY ENDORSING THE DEVELOPMENT OF THE PROPOSED ECO-TOURISM SITE FOR TONTUNAN HEIGHTS IN THE MUNICIPALITY OF CLARIN, BOHOL TO THE REGIONAL DEVELOPMENT COUNCIL — REGION VII (RDC-7) FOR SUPPORT AND FURTHER ENDORSEMENT TO THE DEPARTMENT OF TOURISM (DOT) AND THE TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY (TIEZA) FOR SUPPORT AND FUNDING ASSISTANCE

**WHEREAS**, tourism is one of the economic drivers of the Province of Bohol because of its amazing blend of natural wonders, cultural destinations, geo-ecological endeavors and heritage sites, which impacts on the province's economy through increased economic activities and generation of jobs;

WHEREAS, Clarin is a coastal municipality of Bohol that is endowed with nature's gift of sun, sea and sight (mountain ranges), specifically the cliff formation in barangay Tontunan where one can view the town's landscape, the sea and the nearby islets, and even the City of Cebu during fine weather, which the locals dubbed as the Tontunan Heights;

**WHEREAS**, Tontunan Heights is a natural beauty, very accessible and a great tourism potential that despite its still being under-developed has drawn local tourists and passers-by to have their pictures taken or merely enjoy the serene view especially the varied-hued sunset;

**WHEREAS**, the proximity of Clarin to the Tubigon Port, a major entry point of Bohol, and the recently improved municipal port of Clarin, will make viable the establishment of another promising Countryside Tourism Circuit in northern Bohol that will highlight the Tontunan Heights as a very alluring destination-stop;

WHEREAS, the Tontunan Heights Development Project aims to enhance the general well-being of the rural populace especially the disadvantaged sectors, develop the eco-tourism industry in the area, conserve the natural resources, upgrade the location as a tourist magnet, and contribute in local poverty reduction through livelihood and jobs creation;

WHEREAS, the total project cost amounts to One Hundred Twenty-Two Million (P122 million), brokendown as follows: Construction of Walkways and Trails – P20 M; Infrastructure and Cottages – P20.0 M; Capability Building – P2.5 M; Improvement of Area – P10 M; Equipment – P60

M; Utilities (Electricity and Water) Installation – P7.5 M; and Other Relative Expenses – P2 M;

WHEREAS, the proposed project is in congruence with the province's strategic development priorities of Pag-atiman sa mga Kabus ug Makalolooy, Pagpalambo sa Industriyang Turismo and

Pagpukaw sa Kultura;

WHEREAS, this Body, after discussion on the proposed project, recognizes its potential impact on the tourism industry and economy of Bohol, and thus, finds it worthy of favorable

endorsement;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting

duly convened -

To favorably endorse the proposed Development of the porposed Eco-Tourism Site of Tontunan Heights in the Municipality of Clarin, Bohol to the Regional Development Council – Region VII (RDC-7) for support and further endorsement to the Department of Tourism (DOT) and the Tourism Infrastructure and Enterprise Zone Authority (TIEZA) for support and funding

assistance.

## 1. Project Background:

Clarin is one of the coastal towns of Bohol wherein it is endowed with nature's gift both the sea and mountains. Because of its proximity to the City of Cebu, it is visible if the weather permits. Nestled in Barangay Tontunan, there is a place where one's senses will be cuddled by the panoramic mountain scape and on top of the Mt. Alimono is a 360 degree view of the town's landscape, its bountiful sea as well as its neighboring islets. On the 2010 survey released by PPDO-Bohol, Tontunan landed to the top three barangays which has more than half of its people are below the income threshold level (Table 1) or 51.72%. Considering the economic situation in the said barangay as well as with its adjacent places, an alternative mode of livelihood can be a solution to lower the Income threshold level of the said barangay. Also, since it has been blessed with the immaculate beauty of the nature and the accessibility of the location through the DPWH-DOT Convergence Project, which cut through the proposed area and has a very rustic experience of the country side as well as its vernacular culture, the entire experience is highly regarded as one of a kind. The town's proximity from the major port hub of Tubigon and the possible additional vessels in the Municipal port, we can now move the beginning of Countryside Tourism Circuit in Clarin instead of other neighboring towns. This can be possible once Tontunan Heights will be developed.

## 2. Project Linkages:




Figure 1. Provincial Planning and Development Office (PPDO) Opportunity Map, assigning Clarin under Cluster 3 of its Tourism Theme as Eco-Tourism Area

The main objective of the project is to enhance the general well-being of the rural populace especially the disadvantage sector through Ecological Tourism Industry.

#### Sectoral Objectives:

- a. To develop the eco-tourism industry in the area
- b. To conserve the natural resources
- c. To promote the vernacular culture in the area
- d. To promote the food industry of the Municipality
- e. To upgrade the existing location and become more of a tourist magnet
- To contribute in lessening the poverty incidence in the area as well as in the Municipality

The proposed project supports the national and provincial government Poverty Reduction Program through developing the tourism industry.

### V. PROJECT BENEFICIARIES, BENEFITS and COSTS:

#### 1. Beneficiaries:

Should the project will push through it will be handled and managed by a specific People's Organization (P.O.) composed of local residents of Tontunan and other POs in the adjacent barangays whom also are the direct beneficiaries of the said project.

#### 2. Benefits:

#### a. Social Benefits

Since this includes tourist facilitation and customer service-oriented enterprise, it will improve the interpersonal skills amongst P.O. members who will closely interact with guests. This also opens new career opportunities to other residents who will soon bank on selling agricultural crops and by-products to guests as well as local artifacts. Also, they will be the one who will be capacitated to function as the local guides, entrepreneurs, forest rangers, managers, and workers

#### b. Economic Benefits

Although the direct beneficiaries will be the PO Members and other workers, it will also cater opportunities to other players especially the so called secondary parties (farmers, souvenir makers, land owners, food enthusiast, etc), thus more lives will improve economically.

On the other hand, the area is purely agricultural wherein its assessment value is lower compared to when the area will be developed, thus providing positive traction on the Municipal Revenue.

#### 3. Costs:

#### a. Social Cost:

With the possible influx of tourist and population explosion it may have a drawback to prostitution, possible burglary, and other crimes and health hazards since this is also an adventure park. This can be counter acted by placing office annexes of the Rescue and Emergency Team and Health Unit, Tourism Office, SWM, PNP and other related agencies that will provide immediate solutions and services when the need arises.

#### b. Economic Cost:

The foreseen economic impact aside from the monetary cost is that the proposed area is classified as environmentally critical area (Fig. 2) however, with the coordination and guidance of the Municipal Planning and Development Office, careful planning as well as close-knit coordination with the different line agencies (DENR, MGB, TIEZA, DOT, etc) will definitely ensure solutions and interventions when issues may sprung during its implementation and operation.

Also, it is inevitable that once the area will be fully operational, wastes and other rubbish from irresponsible tourists may be encountered. This can be counter acted by including it during the briefing sessions as well as imposing higher penalties to violators; also, garbage bins and or receptacles will be placed in strategic areas and will be collected daily.
