### PDC EXECOM RESOLUTION NO. 49-C-2021

**A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN (SP) OF BOHOL THE PROPOSED 20 MEGAWATT (MW) DAGOHOY SOLAR POWER PROJECT IN BARANGAY SAN VICENTE, DAGOHOY, BOHOL OF PETROGREEN ENERGY CORPORATION (PGEC) FOR FURTHER ENDORSEMENT TO THE DEPARTMENT OF ENERGY (DoE) AND OTHER CONCERNED AGENCIES**

**WHEREAS**, Republic Act No. 9513, otherwise known as the Renewable Energy Act of 2008, provides that it is the policy of the State to accelerate the exploration and development of renewable energy resources such as but not limited to solar energy including hybrid systems, to achieve energy self-reliance through the adoption of sustainable energy development strategies to reduce the country's dependence on fossil fuels;

**WHEREAS**, the development and utilization of renewable energy resources will be one of the tools to effectively prevent or reduce harmful emissions and thereby balance the goals of economic growth and development with the protection of health and the environment;

**WHEREAS**, the Sangguniang Panlalawigan of Bohol passed Provincial Ordinance No. 2018-005, prohibiting the construction of any coal power plant in Bohol and recognizes the importance of renewable energy as a means to a more sustainable and reliable source of electricity;

**WHEREAS**, PetroGreen Energy Corporation (PGEC) proposed for the establishment of a 20 MW solar power project to be located in **Barangay San Vicente**, Dagohoy, Bohol;

**WHEREAS**, the **Barangay Council of San Vicente**, through **Barangay Resolution 01-2021** dated January 8, 2021, and the **Municipal Development Council (MDC)** of the Municipality of Dagohoy, through **MDC Resolution No. 2 Series of 2021**, interposed No Objection and endorsed the development, construction and operation of the proposed 20 MW Dagohoy Solar Power Project (DSPP) in **Barangay San Vicente, Dagohoy, Bohol**;

**WHEREAS**, the development and operation of the 20 MW Dagohoy Solar Power Project will redound to the socio-economic development of **Barangay San Vicente** and the **Municipality of**

Dagohoy, as host community, through financial benefits warranted under RA 9513, corporate social responsibility projects, and additional job opportunities for the local residents;

**WHEREAS**, the Provincial Government of Bohol, through Executive Order Nos. 1 and 3, Series of 2014, created the Bohol Energy Development Advisory Group (**BEDAG**) as the primary advisory Body tasked to provide advice, recommendations and technical assistance on all matters related to energy and **power** development in Bohol;

**WHEREAS**, the Local Government Code of 1991 mandates the Provincial Development Councils (PDC) to, among others, appraise, prioritize and coordinate the implementation of socio-economic programs and projects within its territorial coverage;

**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –


To favorably endorse to the Sangguniang Panlalawigan (SP) of Bohol the Proposed 20 Megawatt (MW) Dagohoy Solar Power Project (DSPP) in Barangay San Vicente, Dagohoy, Bohol of PetroGreen Energy Corporation (PGEC) for further endorsement to the Department of Energy (**DoE**) and Other Concerned Agencies

**RESOLVED FURTHER**, that the assessment, comments and recommendations of the BEDAG **regarding** the proposed 20 MW DSPP of PGEC will be an integral annotation in this PDC endorsement.


