PDC EXECOM RESOLUTION NO. 51-2021

A RESOLUTION FAVORABLY ENDORSING TO THE CENTRAL VISAYAS REGIONAL DEVELOPMENT COUNCIL – REGION 7 (RDC-7) THE CENTRAL VISAYAS COCONUT FARMERS AND INDUSTRY ROADMAP AND DEVELOPMENT PLAN OF THE PHILIPPINE COCONUT AUTHORITY (PCA) FOR SUPPORT

WHEREAS, with the passage of Republic Act 11524 or the Coconut Farmers and Industry Trust Fund Act, the Philippine Coconut Authority (PCA) is entrusted to prepare the Coconut Farmers and Industry Development Plan (CFIDP) with primary aims of attaining increased income for coconut farmers, reduce poverty, and achieve social equality;

WHEREAS, RA 11524 prescribed that the utilization of the Trust Fund created under the Act, or any portion thereof, shall be in accordance with the Development Plan, which will be submitted for approval by the President of the Philippines, that shall be the basis for its utilization;

WHEREAS, in coordination with the National Economic Development Authority (NEDA) and all the regional counterparts of the different implementing agencies under RA 11524, the CFIDP was formulated to establish the proper perspective in preparing the comprehensive plan that will establish the direction and policies for the development and rehabilitation of the coconut industry in the regions;

WHEREAS, the Central Visayas Regional Coconut Industry Roadmap (CV-COCOFIRM) sets the overall direction for the coconut industry in Region VII, while the Regional Coconut Farmers and Industry Plan (CV-RCFIDP) contains the various Programs and Projects (PAPs) that will be funded by the Coconut Trust Fund;

WHEREAS, the Philippine Coconut Authority (PCA), Regional Office presented the CV-COCOFIRM and the CV-RCFIP to this Body, giving emphasis on their relevance and economic contribution to the coconut industry and the welfare of the coconut farmers;

WHEREAS, after review and deliberation, the proposed Central Visayas Coconut Farmers and Industry Roadmap and Development Plan, has been found by this Body to be supportive to the attainment of Bohol's development goals and objectives, as well as beneficial to the coconut farmers and the development of the coconut industry, and therefore worthy of support and endorsement to the Regional Development Council;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened —

to favorably endorse to the Central Visayas Regional Development Council – Region 7 (RDC-7) the Central Visayas Coconut Farmers and Industry Roadmap and Development Plan of the Philippine Coconut Authority (PCA) for support

RESOLVED FURTHER, to furnish a copy of the same Resolution to the Philippine Coconut Authority (PCA), Department of Agriculture, Regional Office-7 and other agencies concerned for information, guidance and appropriate action.
