PDC EXECOM RESOLUTION NO. 53-B-2021

A RESOLUTION FAVORABLY ENDORSING THE PROPOSED IMPROVEMENT (CONCRETING) OF SITIO LOBLOB-SITIO DIIS KAUSWAGAN ACCESS ROAD, SAN VICENTE-TALIBON-TRINIDAD FARMERS ASSOCIATION (TFJA) FARM TO MARKET ROAD AND MABUHAY CABIGOCHAN-LA UNION FARM TO MARKET ROAD IN THE MUNICIPALITY OF TRINIDAD TO THE REGIONAL DEVELOPMENT COUNCIL – REGION VII (RDC-7) FOR SUPPORT AND FURTHER ENDORSEMENT TO THE NATIONAL TASK FORCE TO END LOCAL COMMUNIST ARMED CONFLICT (NTF-ELCAC)

WHEREAS, Barangays Kauswagan, Mabuhay Cabigohan, La Union and San Vicente are classified as less developed and remote barangays in the Municipality of Trinidad where there were reported sightings of armed insurgents and history of armed conflicts between Government Forces and the armed communist group;

WHEREAS, the aforementioned barangays are identified as Major Production Areas for rice, corn, coconut, cassava, sweet potato, banana and oil palm, where farmers in these areas also raise livestock and poultry as alternative sources of livelihood, to augment their low family income in light of the COVID-19 pandemic;

WHEREAS, 3,160 households in these barangays used to travel to and from the town centers of Trinidad, Ubay, Talibon, Danao and San Miguel by foot, carabaos or two-wheeled vehicles and have to endure the high transportation costs and extensive travel time that can greatly affect the quality of their products and their modest family income;

WHEREAS, the expected increased productivity of the farmers will be through their venturing into the cultivation of new high-value crops, expansion in farm cultivation coverage, and provision of safe and secured routes for the local residents, students and traders thereby improving the community's way of life and the peace and order situation in the area;

WHEREAS, after review and deliberation, the proposed Farm-to-Market road projects and bridges has been found by this Body to be supportive to the attainment of Bohol's development goals towards agricultural productivity and therefore worthy of support and endorsement to the Central Visayas Regional Development Council (RDC-7) and the National Task Force to End Local Communist Armed Conflict (NTF-ELCAC) for their support and funding assistance;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

To Favorably Endorse the Proposed Improvement (Concreting) of Sitio Loblob-Sitio Diis Kauswagan Access Road, San Vicente-Talibon-Trinidad Farmers Association (TTFA) Farm to Market Road and Mabuhay Cabigohan-La Union Farm to Market Road in the Municipality of Trinidad to the Regional Development Council – Region VII (RDC-7) for Support and Further Endorsement to the National Task Force to End Local Communist Armed Conflict (NTF-ELCAC).

RESOLVED FURTHER, to furnish a copy of the same Resolution to the NTF-ELCAC and NEDA Central Office for support and appropriate action.
