### **PDC EXECOM RESOLUTION NO. 60-2021**

**A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN (SP) THE PROPOSED ANNUAL INVESTMENT PROGRAM (AIP) OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR CY 2022 IN THE TOTAL AMOUNT OF TWENTY-NINE BILLION FIVE HUNDRED NINETY-SEVEN MILLION TWO HUNDRED THIRTY-FIVE THOUSAND SEVEN HUNDRED SIXTY PESOS (P29,597,235,760.00), TO INCLUDE THE AMOUNT OF SIX HUNDRED SIXTY MILLION FIVE HUNDRED SIXTY-FOUR THOUSAND SEVEN HUNDRED TWENTY-ONE PESOS (P660,564,721.00) FOR PROGRAMS AND PROJECTS FOR FUNDING UNDER THE 20% DEVELOPMENT FUND, AND TWENTY-THREE BILLION SEVEN HUNDRED ELEVEN MILLION THREE HUNDRED NINETY-FOUR THOUSAND PESOS (P23,711,394,000.000) FOR PROJECTS PROPOSED FOR EXTERNAL FUNDING**

**WHEREAS**, as provided in Joint Memorandum Circular No. 1-2016 of the Department of the Interior and Local Government (DILG), National Economic Development Authority (NEDA), Department of Budget and Management (DBM) and Department of Finance (DOF), and the Budget Operations Manual for Local Government Units, LGUs are mandated to include in their respective Annual Investment Programs (AIPs) total resource requirements of programs, projects and activities for the ensuing year, comprising of the annual capital expenditures and regular operating requirements of the LGU;

**WHEREAS**, in accordance with said Joint Memorandum Circular and the applicable provisions of the Local Government Code (R.A. 7160), the proposed AIP of the Provincial Government of Bohol for CY

2022, taking into consideration the implementation of the Mandanas-Garcia Supreme Court Ruling, the current realities and priorities of the Provincial Government of Bohol to address socio-economic conditions of the province in this time of pandemic, consistent with the three (3) fundamental pillars of development - caring for the weak, re-awakening the Boholano culture, and expanding the tourism economy, has a total investment requirement of **Twenty-Nine Billion Five Hundred Ninety-Seven Million Two Hundred Thirty-Five Thousand Seven Hundred Sixty Pesos (P29,597,235,760.00)**, which covers the proposed requirements for the implementation of various programs, projects and activities (PPAs) of the departments, offices and hospitals of the Provincial Government, including those initiatives incorporated in the proposed Devolution Transition Plan (DTP) of the Provincial Government;

**WHEREAS**, the foregoing amount includes the programs and projects under the 20% Development Fund in the amount of **Six Hundred Sixty Million Five Hundred Sixty-Four Thousand Seven Hundred Twenty-One Pesos (P660,564,721.00)**, proposed projects for external funding, in the amount of **Twenty-Three Billion Seven Hundred Eleven Million Three Hundred Ninety-Four Thousand Pesos (P23,711,394,000.000)**, and Investment requirement for 2022 of the Local Economic Enterprise of **Twelve Million Six Hundred Fifty Thousand Pesos (P12,650,000.00)**;

**WHEREAS**, the proposed investment program prioritizes on initiatives that allow the Provincial Government to effectively manage the risk and improve the province's resiliency for emerging and re-emerging disease, while stimulating the local economy by putting more investments for agriculture, promotion of livelihood and employment, sustaining ongoing efforts for the revival of tourism industry and expansion of social services and direct assistance, and other services devolved to the Provincial Government to continue to cater to the needs of Boholanos;

**WHEREAS**, the PPAs on this Investment Program for the year 2022, will correspondingly be included as part of the investment items in the current Local Development Investment Plan (LDIP) of the Province of Bohol;

**WHEREAS**, implementation of these proposed programs, projects and activities, with detailed breakdown thereof set forth in the attached list and made an integral part of this Resolution, will have to be subject to the availability of funds of the Provincial Government of Bohol, and made available through approved Appropriation Ordinance, or available external funding from the national government, Official Development Assistance (ODA) organizations, and other sources;



**WHEREAS**, this proposed list of projects under the AIP for CY 2022, after due presentation to this Body and its subsequent deliberation, has been found to be in order in form and substance, thus worthy of favorable endorsement to the Sangguniang Panlalawigan for approval;


**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

**to favorably endorse to the Sangguniang Panlalawigan (SP) the Proposed Annual Investment Program (AIP) of the Provincial Government of Bohol for CY 2022, in the total amount of Twenty-Nine Billion Five Hundred Ninety-Seven Million Two Hundred Thirty-Five Thousand Seven Hundred Sixty Pesos (P29,597,235,760.00), to include the amount of Six Hundred Sixty Million Five Hundred Sixty-Four Thousand Seven Hundred Twenty-One Pesos (P660,564,721.00) for Programs and Projects Proposed for Funding under the 20% Development Fund, and Twenty-Three Billion Seven Hundred Eleven Million Three Hundred Ninety-Four Thousand Pesos (P23,711,394,000.00) for Projects Proposed for External Funding**
