### **PDC EXECOM RESOLUTION NO. 61-2021**

**A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN OF BOHOL THE PROPOSAL TO ADD THE SUPPLEMENTAL AMOUNT OF TEN MILLION SIX HUNDRED TWENTY THOUSAND (PHP 10,620,000.00) TO THE INVESTMENT PROGRAM OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR CY 2021**

**WHEREAS**, the Provincial Government of Bohol, has identified additional priority programs, projects and activities (PPAs) in the year 2021 for the promotion of the welfare of health care workers and for the support for the management of emerging and re-emerging diseases and COVID-19,

**WHEREAS**, these PPAs are expected to provide better compensation to health care workers, particularly nurses, pursuant to Budget Circular No. 2021-2 of the DBM, and sustain management and response efforts of COVID-19;

**WHEREAS**, these additional PPAs will require an estimated total amount of **Ten Million Six Hundred Twenty Thousand (PHP 10,620,000.00)**, which correspondingly is the proposed supplemental requirement in the Investment Program (IP) of the Province of Bohol for CY 2021, with the copy of the Supplemental Investment Program (SIP) No. 6 attached hereto and made an integral part hereof;

**WHEREAS**, these PPAs, constituting the SIP No. 6 for the year 2021, will correspondingly be treated as supplemental investment items in the current Local Development Investment Plan (LDIP) of the Province of Bohol;

**WHEREAS**, funding for these PPAs will be obtained from resources of the Provincial Government such as the current year's savings of appropriated salaries and other benefits of vacant positions and MOOE, unexpended balances from the prior years' annual and supplemental appropriations with cash back-up that may be made available thru an Appropriation Ordinance authorizing the Supplemental Budget and from external sources such as funds from the national government;

**WHEREAS**, as provided in the Joint Memorandum Circular No. 01-2007 and JMC No. 1 2016 of the Department of the Interior and Local Government (DILG), National Economic Development Authority (NEDA), Department of Budget and Management (DBM) and the Department of Finance (DOF), as well as the Budget Operations Manual (BOM) of the DBM, local government units (LGUs) are mandated to support all budgets with corresponding investment programs;

**WHEREAS**, the PPAs proposed under the SIP No. 6 for CY 2021, after review and deliberation, have been found by this Body to be in order, consistent to and responsive to provincial development priorities, thus worthy of approval;

**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

**to favorably endorse to the Sangguniang Panlalawigan of Bohol the Proposal to Add the Supplemental Amount of Ten Million Six Hundred Twenty Thousand (PHP 10,620,000.00) to the Investment Program of the Provincial Government of Bohol for CY 2021**

### **PDC EXECOM RESOLUTION NO. 62-2021**

**A RESOLUTION APPROVING THE DEVOLUTION TRANSITION PLAN (DTP) OF THE PROVINCE OF BOHOL FOR CY 2022-2024 AND FAVORABLY ENDORSING THE SAME TO THE SANGGUNIANG PANLALAWIGAN (SP) OF THE PROVINCE OF BOHOL FOR THEIR APPROVAL AND SUPPORT**

**WHEREAS**, Section 25, Article II of the Philippine Constitution provides that the State shall ensure the autonomy of local governments;

**WHEREAS**, Section 2 (a) of the Local Government Code (LGC) of 1991 (Republic Act No. 7160) provides that the State shall provide for a more responsive and accountable local government structures instituted through a system of decentralization whereby local government units (LGUs) shall be given more powers, authority, responsibilities, and resources. The process of decentralization shall proceed from the national government (NG) to the local government units (LGUs);

**WHEREAS**, the Supreme Court (SC) decision in the consolidated cases of *Congressman Hermilando I. Mandanas, et al vs. Executive Secretary Paquito Ochoa, et al* and *Honorable Enrique T. Garcia, Jr. vs. Executive Secretary Paquito Ochoa, et al* clarifies the basis for the computation of local government shares and ordered the national government to include all collections of national taxes in the computation of the base amount for the just share of LGUs;

**WHEREAS**, Executive Order No. 138, s. 2021 orders the full devolution of functions, services and facilities by the national government (NG) to local government (LGUs) not later than the end of 2024. These shall include those devolved responsibilities indicated in Section 17 of RA 7160 and in other existing laws which subsequently devolved functions of the NG to LGUs. These fully devolved responsibilities shall be funded from the shares of the LGUs in the proceeds of the national taxes and other local revenues;

**WHEREAS**, the DBM-DILG Joint Memorandum Circular (JMC) No. 2021 requires all LGUs to prepare the DTPs to ensure a strategic perspective and systematic and coherent actions towards their full assumption of devolved functions and services starting in FY 2022;


**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

to approve the Devolution Transition Plan (DTP) of the Province of Bohol for CY 2022-2024 and favorably endorse the same to the Sangguniang Panlalawigan (SP) of the Province of Bohol for their Approval and Support.
