PDC EXECOM RESOLUTION NO. 64-2021

A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN OF BOHOL THE PROPOSAL TO ADD THE SUPPLEMENTAL AMOUNT OF FORTY-ONE MILLION NINE HUNDRED TWENTY-FIVE THOUSAND PESOS (PHP41,925,000.00) TO THE INVESTMENT PROGRAM OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR CY 2021

WHEREAS, the Provincial Government of Bohol, guided by its development priorities and principle of good governance, has identified additional priority initiative for the year 2021, with the issuance of Budget Circular No. 2021-3 by the Department of Budget and Management, particularly for the grant of Collective Negotiation Agreement (CNA) Incentives for 2021;

WHEREAS, the CNA Incentive shall be granted to qualified management and rank-and-file employees of the Provincial Government of Bohol, pursuant to the approved and successfully implemented CNA in recognition of the efforts made in accomplishing performance targets at lesser cost, attaining more efficient and viable operations through cost-cutting measures and systems improvement;

WHEREAS, the grant of CNA Incentive will require an estimated total amount of Forty-One Million Nine Hundred Twenty-Five Thousand Pesos (PHP41,925,000.00), which is the proposed supplemental requirement in the investment program (IP) of the Provincial Government of Bohol for 2021, with the copy of the Supplemental Investment Program (SIP) No. 9 attached hereto and made an integral part hereof;

WHEREAS, these additional PPAs, as part of the Supplemental Investment Program for the year 2021, will correspondingly be included as supplemental investment items in the current Local Development Investment Plan (LDIP) of the Province of Bohol;

WHEREAS, funding for this Supplemental Investment Program will be obtained from available resources as a result in the implementation of cost-cutting and systems improvement measures undertaken collectively by the Provincial Government management and its personnel, consistent with the guidelines set in DBM Budget Circular No. 2021-3. The funds can be used for the purpose through the approval of a Supplemental Budget through an Appropriation Ordinance;

WHEREAS, the proposed Supplemental Investment Program, after review and deliberation, has been found by this Body to be in order, aligned with the provincial thrust of providing allowable incentives and benefits to its personnel and worthy of favorable endorsement to the Sangguniang Panlalawigan for approval;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

to favorably endorse to the Sangguniang Panlalawigan of Bohol the proposal to add the supplemental amount of Forty-One Million Nine Hundred Twenty-Five Thousand Pesos (PHP41,925,000.00) to the Investment Program of the Provincial Government of Bohol for CY 2021
