PDC EXECOM RESOLUTION NO. 65-2021

A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN OF BOHOL THE PROPOSAL TO ADD THE SUPPLEMENTAL AMOUNT OF SIXTEEN MILLION SIX-HUNDRED SEVENTY THOUSAND PESOS (PHP16,670,000.00) TO THE INVESTMENT PROGRAM OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR CY 2021

WHEREAS, the Provincial Government of Bohol, guided by its development priorities and principle of good governance, has identified additional priority initiative for the year 2021, with the issuance of Administrative Order No. 45 by the Office of the President dated December 24, 2021, authorizing the grant of Service Recognition Incentive (SRI) to government employees for fiscal year 2021;

WHEREAS, the government continues to acknowledge all public servants for their collective and unceasing participation in and invaluable contribution to the establishment of streamlined government processes and responsive delivery of public services, especially in the midst of public health emergency caused by the COVID-19 pandemic;

WHEREAS, it is imperative to provide reasonable incentives and assistance to public servants, who are impacted not only by the pandemic, but also by various natural calamities like the recent Typhoon Odette;

WHEREAS, the grant of Service Recognition Incentive will require an estimated total amount of **Sixteen Million Six-Hundred Seventy Thousand Pesos (PHP16,670,000.00)**, which is the proposed supplemental requirement in the investment program (IP) of the Provincial Government of Bohol for

2021, with the copy of the Supplemental Investment Program (SIP) No. 8 attached hereto and made an integral part hereof;

WHEREAS, these additional activity for the benefit of qualified Provincial Government personnel, as part of the Supplemental Investment Program for the year 2021, will correspondingly be included as supplemental investment items in the current Local Development Investment Plan (LDIP) of the Province of Bohol;

WHEREAS, funding for this Supplemental Investment Program will be obtained from available resources, as authorized under said Administrative Order No. 45, to be consistent with appropriate Budget Circular and Guidelines. The funds can be used for the purpose through the approval of a Supplemental Budget through an Appropriation Ordinance;

WHEREAS, the proposed Supplemental Investment Program, after review and deliberation, has been found by this Body to be in order, aligned with the provincial thrust of providing allowable incentives and benefits to its personnel and worthy of favorable endorsement to the Sangguniang Panlalawigan for approval;


WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –


