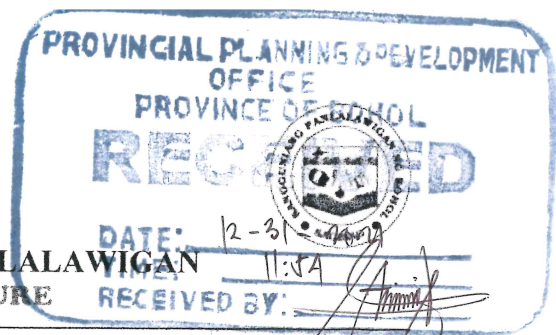

“WHEREAS, deliberated by this August Body was the letter of the Honorable Governor Arthur C. Yap, dated December 30, 2021, transmitting ExeCom Resolution No. 66-2021 of the Provincial Development Council, which favorably endorses the proposal to add the supplemental amount of Twenty-One Million Seven Hundred Fifty Thousand Pesos (Php21,750,000.00) to the Investment Program of the Provincial Government of Bohol for CY 2021;

“WHEREAS, the Provincial Government of Bohol, has identified additional priority initiative for the year 2021, with the issuance of Administrative Order No. 46 by the Office of the President dated December 29, 2021, authorizing the grant of Gratuity Pay to Contract of Service (COS) and Job Order (JO) Workers in Government Service for Fiscal Year 2021;

“WHEREAS, while COS and JO workers in government are paid salaries/wages, they do not enjoy benefits accorded to regular government employees such as Personnel Economic Relief Allowance (PERA), Mid-Year and Year-End Bonuses and Performance-Based Bonus, as they have no employer-employee relationship with government;

“WHEREAS, as emphasized in the Administrative Order No. 46, the granting of a year-end Gratuity Pay to Contract of Service and Job Order workers is a well-deserved recognition of their hard work in implementing programs, projects and activities, including those which are part of the emergency COVID-19 response efforts of the Provincial Government of Bohol;

“WHEREAS, the grant of the Gratuity Pay to COS and JO workers shall further encourage the commitment and hard work of such workers in the performance of their assigned functions that will ultimately contribute to the attainment of the Province’s development goals;

“WHEREAS, these additional initiative for the benefit of qualified Provincial Government COS and JO workers, as part of the Supplemental Investment Program for the year 2021, will correspondingly be included as supplemental investment items in the current Local Development Investment Plan (LDIP)of the Province of Bohol;

“WHEREAS, this Body finds the request in order and aligned with the provincial thrust of providing due allowable incentives and benefits to promote the welfare to its workers following the set guidelines;

“WHEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Panlalawigan of Bohol in session duly assembled –

To approve ExeCom Resolution No. 66-2021 of the Provincial Development Council, favorably endorsing to this August Body the proposal to add the supplemental amount of Twenty-One Million Seven Hundred Fifty Thousand Pesos (Php21,750,000.00) to the Investment Program of the Provincial Government of Bohol for CY 2021.

### **PDC EXECOM RESOLUTION NO. 66-2021**

**A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN OF BOHOL THE PROPOSAL TO ADD THE SUPPLEMENTAL AMOUNT OF TWENTY-ONE MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS (PHP21,750,000.00) TO THE INVESTMENT PROGRAM OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR CY 2021**

**WHEREAS**, the Provincial Government of Bohol, has identified additional priority initiative for the year 2021, with the issuance of Administrative Order No. 46 by the Office of the President dated December 29, 2021, authorizing the grant of Gratuity Pay to Contract of Service (COS) and Job Order (JO) Workers in Government Service for fiscal year 2021;

**WHEREAS**, while COS and JO workers in government are paid salaries/ wages, they do not enjoy benefits accorded to regular government employees such as Personnel Economic Relief Allowance (PERA), Mid-Year and Year-End Bonuses and Performance-Based Bonus, as they have no employer-employee relationship with government;

**WHEREAS**, the grant of Gratuity Pay to qualified Contract of Service and Job Order Workers of the Provincial Government will require an estimated total amount of **Twenty One Million Seven Hundred Fifty Thousand Pesos (PHP21,750,000.00)**, which is the proposed supplemental requirement in the investment program (IP) of the Provincial Government of Bohol for 2021, with the copy of the Supplemental Investment Program (SIP) No. 9 attached hereto and made an integral part hereof;

**WHEREAS**, these additional initiative for the benefit of qualified Provincial Government COS and JO workers, as part of the Supplemental Investment Program for the year 2021, will correspondingly be included as supplemental investment items in the current Local Development Investment Plan (LDIP) of the Province of Bohol;

**WHEREAS**, funding for this Supplemental Investment Program will be obtained from available resources, as authorized under said Administrative Order No. 46, to be consistent with appropriate Budget Circular and Guidelines. The funds can be used for the purpose through the approval of a Supplemental Budget through an Appropriation Ordinance;

**WHEREAS**, the proposed Supplemental Investment Program, after review and deliberation, has been found by this Body to be in order, proper and aligned to the provincial thrust of providing allowable pay to its personnel and worthy of favorable endorsement to the Sangguniang Panlalawigan for approval;


**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –


