PDC-EXECOM RESOLUTION NO. 52 - 2023

A RESOLUTION FAVORABLY ENDORSING THE PROPOSED PORT ZONE DELINEATION (PZD) IN THE PORT OF MARIBOJOC IN THE MUNICIPALITY OF MARIBOJOC, PROVINCE OF BOHOL TO THE CENTRAL VISAYAS REGIONAL DEVELOPMENT COUNCIL (RDC) AND SUBSEQUENTLY SUBMITTED TO THE OFFICE OF THE PRESIDENT FOR SUPPORT AND APPROVAL

WHEREAS, a Port Zone Delineation (PZD) is an imaginary line that identifies the extent of the administrative jurisdiction and authority of the Philippine Ports Authority (PPA) over a specific area;

WHEREAS, the PZD is to redirect and recognize port administration for the full development of port districts in the Philippines, over which, the PPA can provide and construct port facilities and amenities, stimulates economic activities and business opportunities in the port area and encourages efficient land use;

WHEREAS, the proposed PZD in the Port of Maribojoc is to be located in Barangay Poblacion, Maribojoc, Bohol, which was concurred and approved by the Sangguniang Bayan of Maribojoc;

WHEREAS, the Local Government Unit (LGU) of Maribojoc and the Philippine Ports Authority (PPA), through their respective representatives, discussed and agreed on the PZD in the Maribojoc Port;

WHEREAS, the proposed PZD covers an area of 100,000 square meters, with the following technical description:

Technical Descriptions			
Line		Bearing	Distance
1	2	Due East	500.0 m.
2	3	Due South	200.0 m.
3	4	Due West	500.0 m.
4	1	Due North	200.0 m.

WHEREAS, after careful study and consideration of the PZD, the LGU of Maribojoc and the PPA finally agreed on its approval;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened -


To favorably endorse the proposed Port Zone Delineation (PZD) in the Port of Maribojoc in the Municipality of Maribojoc, Province of Bohol to the Central Visayas Regional Development Council (RDC) and subsequently submitted to the Office of the President for support and approval.

RESOLVED FURTHER, to furnish a copy of this Resolution to the PPA Central Office and to Hon. Edgar M. Chatto, 1st Congressional District of Bohol for their support and follow-up.
