PDC EXECOM RESOLUTION NO. 57-2023

A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN OF BOHOL THE APPROVAL OF THE DETAILED DEVELOPMENT PROJECTS TO BE FUNDED UNDER THE LINE ITEMS OF THE 20% DEVELOPMENT FUND IN THE 2023 ANNUAL BUDGET OF THE PROVINCIAL GOVERNMENT OF BOHOL, PARTICULARLY THE SUPPORT FOR SOCIO-ECONOMIC DEVELOPMENT OF BARANGAYS IN THE TOTAL AMOUNT OF FIFTY-FOUR MILLION NINE HUNDRED NINETY-NINE THOUSAND NINE HUNDRED EIGHTY-EIGHT PESOS (P54,999,988.00) AND THE SUPPORT FOR SOCIO-ECONOMIC DEVELOPMENT FOR MUNICIPALITIES IN THE TOTAL AMOUNT OF SIXTY MILLION PESOS (P60,000,000.00) AND TO AUTHORIZE THE GOVERNOR FOR THEIR IMPLEMENTATION

WHEREAS, the Provincial Government of Bohol, through its 2023 Annual Budget, has allocated under its 20% Development Fund a lumpsum amount of Fifty-Six Million Six Hundred Thousand (P56,600,000.00) for Support for Socio-Economic Development of Barangays and another Sixty Million Pesos (P60,000,000.00) for Support for Socio-Economic Development of Municipalities;

WHEREAS, such line items in the Annual Budget are consistent with the 2023 Annual Investment Program (AIP) of the Provincial Government of Bohol, as endorsed by the Provincial Development Council through PDC ExeCom Resolution No. 55-2022 and approved through Sangguniang Panlalawigan Resolution No. 2022-857;

WHEREAS, per pertinent Department of Budget and Management (DBM) guidelines, and Joint Memorandum Circular No. 1 of the DBM, Department of Finance (DOF) and the Department of the Interior and Local Government (DILG), the 20% DF shall be utilized to finance the Local Government Unit's priority development projects, as embodied in their respective duly approved local development plans and annual investment programs, and that these projects shall be necessary, appropriate, or incidental to the efficient and effective local governance, which are essential to the promotion of the general welfare of the people;

WHEREAS, the Office of the Governor, through assessment, consultation, and collaboration with barangay and municipal local government units, has identified specific programs, projects and activities, that will be funded from the line items under the 20% Development Fund of the CY 2023 Annual Budget particularly the Support for Socio-Economic Development of Barangays in the total amount of **Fifty-Four Million Nine Hundred Ninety-Nine Thousand Nine Hundred Eighty-Eight Pesos (P54,999,988.00)** and Support for Socio-Economic Development of Municipalities in the total amount of Sixty Million Pesos (P60,000,000.00), which will compose the detailed development projects to be incorporated in the Annual Investment Program for CY 2023 and current Local Development Investment Plan (LDIP) of the Province of Bohol, with the copy of the list of Projects attached hereto and made an integral part hereof;

WHEREAS, the development projects, after review and deliberation, have been found by this Body to be in order, supportive to the development priorities of the barangay and municipal local government units and the Province, in general, and therefore worthy of endorsement to the Sangguniang Panlalawigan for approval and further to authorize the Governor for their implementation through proper and applicable implementation arrangements with municipal and barangay local government units concerned, subject to government budgeting, accounting and auditing rules and regulations;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

to favorably endorse to the Sangguniang Panlalawigan of Bohol the approval of the detailed development projects to be funded under the line items of the 20% Development Fund in the 2023 Annual Budget of the Provincial Government of Bohol, particularly the Support for Socio-economic Development of Barangays in the total amount of Fifty-Four Million Nine Hundred Ninety-Nine Thousand Nine Hundred Eighty-Eight Pesos (P54,999,988.00) and the Support For Socio-Economic Development for Municipalities in the total amount of Sixty Million Pesos (P60,000,000.00) and to authorize the Governor for their Implementation
