#### PDC - EXECOM RESOLUTION NO. 60-2023

A RESOLUTION FAVORABLY ENDORSING THE TWO (2) RESETTLEMENT PROJECTS OF SIERRA BULLONES ESKAYA RESETTLEMENT PROJECT AMOUNTING TO TWENTY-SEVEN MILLION SEVEN HUNDRED FIFTY-FIVE THOUSAND FOUR HUNDRED TWENTY-EIGHT PESOS AND 44/100 (PHP 27,755,428.44) AND PILAR ESKAYA RESETTLEMENT PROJECT AMOUNTING TO TWENTY-SIX MILLION FIVE HUNDRED FORTY-SIX THOUSAND FIVE HUNDRED NINETY-FOUR PESOS AND 16/100 (PHP 26,546,594.16) TO THE REGIONAL DEVELOPMENT COUNCIL (RDC) REGION VII, CEBU CITY

WHEREAS stipulated in Section 25 of the Republic Act no. 8371, otherwise known as the Indigenous People's Right Act of 1997, the Indigenous Cultural Communities (ICCs) and Indigenous Peoples (IPs) have the right to special measures for the immediate, effective, and continuing improvement of their economic and social conditions, including housing services;

WHEREAS, there was an NHA Memorandum Circular No. 2020-037 issued to supplement Memorandum Circular No. 2018-029 prescribing the Guidelines for the implementation of the Housing Assistance Program for the Indigenous Cultural Communities (ICCs) and Indigenous Peoples (IPs);

WHEREAS, there is an immediate need to provide housing assistance to some 34 Indigenous People occupying 0.77952 hectares portion of their ancestral domain property located in Cantaub, Sierra Bullones, and 0.8047 hectares to 40 IP families in Lundag, Pilar all in the Province of Bohol that were greatly affected by the typhoon Odette in order to uplift their lives and improve their living conditions by providing the decent housing within their ancestral domain;

WHEREAS, the project comprises the Housing Construction, a grant from the Chinese Government and will be implemented through Limited Source Bidding while the Land Development will be funded by the National Housing Authority (NHA) and will be

implemented through competitive bidding. Below is the table for the proposed Eskaya Resettlement Project:

WHEREAS the Municipalities of Pilar through its Municipal Zoning Administrator has certified that the location of the proposed project site of the resettlement is within the Built-up Zone of the barangay Lundag and it is currently used as a residential area;

WHEREAS the Municipalities of Sierra Bullones has certified through its Municipal Zoning Administrator that the location of the proposed project site is classified as a Resettlement Zone for IPs of the barangay Cantaub;

WHEREAS the Municipal Development Councils of LGU Sierra Bullones and Pilar favorably endorsed the said projects through MDC Resolution No. 003 Series of 2024 and MDC Resolution No. 3 Series of 2023 respectively;

WHEREAS the proposed projects are aligned with and supportive of the 2016-2028 Provincial Development and Physical Framework Plan and the Strategic Governance Roadmap particularly in the area of inclusive social services through the provision of resilient and livable housing units, hence the projects are consistent with the LGUs Land Use Plan;

WHEREAS, upon thorough discussion and deliberation during the Provincial Development Council Executive Committee, the body decided to approve the endorsement of this resolution;

**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

To favorably endorse the Proposed Projects of Sierra Bullones Eskaya Resettlement Project amounting to Twenty-Seven Million Seven Hundred Fifty-Five Thousand Four Hundred Twenty-Eight Pesos and 44/100 (Php 27,755,428.44) and Pilar Eskaya Resettlement Project amounting to Twenty Six Million Five Hundred Forty-Six Thousand Five Hundred Ninety-Four Pesos and 16/100 (Php 26,546,594.16, Province of Bohol to the Central Visayas Regional Development Council (RDC).

**RESOLVED FURTHER**, to furnish a copy of the same resolution to the Regional Development Council, National Housing Authority (NHA), and National Economic Development Authority (NEDA) for its review and approval.
