### PDC EXECOM RESOLUTION NO. 67-2023

**A RESOLUTION FAVORABLY ENDORSING TO THE CENTRAL VISAYAS REGIONAL DEVELOPMENT COUNCIL - REGION VII (RDC-7) THE PROPOSED SEVENTEEN (17) PANG-AGRARYONG TULAY PARA SA BAGONG BAYANIHAN NG MGA MAGSASAKA (PBBM) BRIDGES FOR BOHOL PROVINCE FOR SUPPORT AND FUNDING**

**WHEREAS**, the Pang-Agraryong Tulay Para Sa Bagong Bayanihan Ng Mga Magsasaka (PBBM) Bridges aims to improve access of the people to a more safe and efficient infrastructure specifically for the agricultural sector;
