#### PDC EXECOM RESOLUTION NO. 70-2023

A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN OF BOHOL THE PROPOSAL TO ADD THE SUPPLEMENTAL AMOUNT OF FIFTY-NINE MILLION FIVE HUNDRED ONE THOUSAND SEVEN HUNDRED ONE PESOS AND SEVENTY-FIVE CENTAVOS (PHP 59,501,701.75) TO THE INVESTMENT PROGRAM OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR CY 2023

WHEREAS, the Provincial Government of Bohol, guided by its strategic governance roadmap and development priorities, has identified additional projects and activities for the year 2023 to include the improvement of the old Provincial Library to office space for the Bohol Provincial Tourism Office, professional services for the Teodoro B. Galagar District Hospital, procurement of power generator set for the Bohol District Jail and construction of storage room/ supply building for the Bohol District Jail (BDJ), payment of tax liabilities on office space rental income to the BIR, grant of the CY 2023 Collective Negotiation Agreement (CNA) Incentive to qualified personnel and management of the Provincial Government of Bohol;

WHEREAS, these additional initiatives will require an estimated total amount of Fifty-Nine Million Five Hundred One Thousand Seven Hundred One Pesos and Seventy-Five Centavos (PHP59,501,701.75), which correspondingly is the proposed supplemental requirement in the Investment Program (IP) of the Province of Bohol for CY 2023, with the copy of the Supplemental Investment Program (SIP) No. 5 attached hereto and made an integral part hereof;

**WHEREAS**, the initiative constituting the SIP No. 5 for the year 2023, will correspondingly be treated as supplemental investment items in the current Local Development Investment Plan (LDIP) of the Province of Bohol;



WHEREAS, funding for the initiative is proposed to be sourced from resources within the Provincial Government of Bohol such as the Salary savings of 2023, proposed prior years' reversion and re-appropriation of Capital Outlay - 2017-012 Regular (2018) BPTO for the improvement of Bohol Tourism Office, 2022 Capital Outlay of BDJ Construction of Multi-Purpose Covered Court (2021-030), and 2023 General Fund/ LEE - Allowable maintenance and other operating expenses (MOOE) accounts pursuant to DBM BC No. 2023-1 for the grant of the CNA incentive, with cash back-up, that may be made available thru an Appropriation Ordinance authorizing a Supplemental Budget;

WHEREAS, as provided in the Joint Memorandum Circular No. 01-2007 and JMC No. 1 2016 of the Department of the Interior and Local Government (DILG), National Economic Development Authority (NEDA), Department of Budget and Management (DBM) and the Department of Finance (DOF), as well as the Budget Operations Manual (BOM) of the DBM, local government units (LGUs) are mandated to support all budgets with corresponding investment plans;

**WHEREAS**, the projects and activities under this SIP No. 5 for CY 2023, after review and deliberation, have been found by this Body to be in order, supportive to the current and long-term development priorities of the Province to include the provision of incentives to qualified personnel and therefore worthy of approval and endorsement to the Sangguniang Panlalawigan;

**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

to favorably endorse to the Sangguniang Panlalawigan of Bohol the proposal to add the Supplemental amount of Fifty-Nine Million Five Hundred One Thousand Seven Hundred One Pesos and Seventy-Five Centavos (PHP59,501,701.75) to the Investment Program of the Provincial Government of Bohol for CY 2023.
