### PDC FULL COUNCIL RESOLUTION NO. 04-2024

A RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN OF BOHOL THE PROPOSAL TO ADD THE SUPPLEMENTAL AMOUNT OF THIRTY-FOUR MILLION FIVE HUNDRED SIXTY THOUSAND PESOS (PHP34,560,000.00) TO THE INVESTMENT PROGRAM OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR CY 2024 INCLUDING ITS PROPOSED FUND SOURCES

WHEREAS, the Provincial Government of Bohol, guided by its strategic governance roadmap and change agenda, has identified additional initiative for the year 2024 that needs funding, which covers the grant of the Service Recognition Incentive (SRI) for CY 2024 to qualified employees of the Provincial Government of Bohol pursuant to Executive Order No. 27 of the Office of the President, in recognition of the hard work and commitment of government personnel to public service;

WHEREAS, the additional initiative will require an estimated total amount of Thirty-Four Million Five Hundred Sixty Thousand Pesos (PHP34,560,000.00), which correspondingly is the proposed supplemental requirement in the Investment Program (IP) of the Province of Bohol for CY 2024, with the copy of the Supplemental Investment Program (SIP) No. 8 summary form attached hereto and made an integral part hereof;

**WHEREAS**, the initiative constituting the SIP No. 8 for the year 2024, will correspondingly be treated as supplemental investment items in the current Local Development Investment Plan (LDIP) of the Province of Bohol;

WHEREAS, the PDC, noting on the investment requirements for the initiative under the SIP, has been presented with the recommendation for the approval of the proposed sources from the savings from salaries and other personal benefits of vacant positions for the month covering October and November 2024, savings from Hazard Pay allocation of vacant positions from July to November 2024, and from savings from the maintenance and other operating expenses, both for the general fund and local economic enterprise- Café Caloy, all with cash back-up, and may be made available thru an Appropriation Ordinance authorizing a Supplemental Budget as will be approved by the Sangguniang Panlalawigan;

whereas, as provided in the Joint Memorandum Circular No. 01-2024 of the Department of the Interior and Local Government (DILG), Department of Human Settlements and Urban Development (DHSUD), National Economic Development Authority (NEDA), Department of Budget and Management (DBM) and the Department of Finance (DOF), as well as the Budget Operations Manual (BOM) for local government units (LGUs), local budgets shall be based on approved annual investment programs, as the budget operationalizes approved local development plans;

**WHEREAS**, the initiative under this SIP No. 8 for CY 2024, after review and deliberation, have been found by this Body to be in order, supportive to the development priorities of the Provincial Government, in particular giving recognition of the hard work, dedication, commitment and accomplishments of personnel of the Provincial Government of Bohol for CY 2024, and therefore worthy of endorsement to and approval by the Sangguniang Panlalawigan;

**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

to favorably endorse to the Sangguniang Panlalawigan of Bohol the Proposal to Add the Supplemental amount of Thirty-Four Million Five Hundred Sixty Thousand Pesos (PHP34,560,000.00), to the Investment Program of the Provincial Government of Bohol for CY 2024 including its Proposed Fund Sources
