PDC-EXECOM RESOLUTION NO. 43-2024

A RESOLUTION FAVORABLY ENDORSING TO THE CENTRAL VISAYAS REGIONAL DEVELOPMENT COUNCIL OF REGION VII (RDC-7), DEPARTMENT OF TRANSPORTATION (DOTr) AND THE PHILIPPINE PORTS AUTHORITY (PPA) THE PROPOSED IMPROVEMENT OF THE CANDIJAY MUNICIPAL PORT FOR INCLUSION IN THE REGIONAL DEVELOPMENT INVESTMENT PROGRAM (RDIP)

WHEREAS, the municipality of Candijay has an existing municipal port located in Barangay Panas that is as strategically located as an entry point for passengers coming from Southern Leyte and the provinces of Camiguin and Surigao in Mindanao;

WHEREAS, the Candijay Municipal Port is near the Candijay Campus of the Bohol Island State University (BISU) and is used as docking facility for fisherfolks and international or domestic travelers going to such famous tourism sites like the Anda Peninsula, Alicia Panoramic Park, Can-umantad Falls and the Cadapdapan Rice Terraces;

WHEREAS, the proposed improvement of the Candijay Municipal Port is seen to spur the economic activities and the business environment of Candijay and that improving its anchorage capacity of approximately 300 meter extension will make it as an alternative port for vessels docking in the Eastern and Northeastern side of Bohol that are plying the Bohol - Leyte, Bohol - Camiguin and Bohol- Surigao route;

WHEREAS, the proposed improvement activities will include the preparation of a Feasibility Study and Detailed Engineering Design (DED) proposed to be funded by the Philippine Ports Authority (PPA) through its Infrastructure Development Program in the amount of P300,000,000.00;

WHEREAS, the proposed project supports the Regional Development Plan strategy of improving transport network that serves the needs of the people and promotes greater access to markets, production areas and vital

industries through enhanced infrastructure and inter-island connectivity and is a viable economic program which is consistent with the strategies of the Bohol Provincial Development and Physical Framework Plan (PDPFP) and supportive and aligned to the Bohol Strategic Governance Roadmap and the Comprehensive Land Use Plan (CLUP) of the Municipality of Candijay;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened -

To favorably endorse to the Central Visayas Regional Development Council of Region VII (RDC-7), Department of Transportation (DOTr) and the Philippine Ports Authority (PPA) the proposed improvement of the Candijay Municipal Port for inclusion in the Regional Development Investment Program

RESOLVED FURTHER, to furnish copies of the same Resolution to the PPA Regional Office and Honorable Kristine Alexie B. Tutor, Representative of the 3rd Congressional District of Bohol, for their support and follow-up.
