PDC EXECUTIVE COMMITTEE RESOLUTION NO. 45-2024

A RESOLUTION FAVORABLY ENDORSING THE PROPOSED PROJECTS FOR THE PROVINCE OF BOHOL UNDER THE PANAHON NG PAGKILOS: COMMUNITY-DRIVEN CLIMATE ACTION OF THE WORLD BANK (WB)-DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) TO THE CENTRAL VISAYAS REGIONAL DEVELOPMENT COUNCIL (RDC-7) FOR SUPPORT AND FURTHER ENDORSEMENT TO THE NATIONAL ECONOMIC DEVELOPMENT AUTHORITY (NEDA)

WHEREAS, the Philippines is one of the most disaster-prone countries in the world where about 20 cyclones enter the country every year and other natural calamities day regularly occurred due to its geophysical location and characteristics;

WHEREAS, the Department of Social Welfare and Development (DSWD) had been implementing the Kapit-Bisig Laban sa Kahirapan-Comprehensive and Integrated Delivery of Social Services (KALAHY-CIDSS), a 20-year program that has helped the poor, vulnerable and marginalized, with its community-driven development (CDD) approach which empowers the communities to manage infrastructure projects that address their identified needs, enables the immediate assessment of disaster impacts and convergence of efforts to build disaster-resilient sub-projects and provide timely services after the disaster;

WHEREAS, the local government units (LGUs) in the Province of Bohol are recipients and willing cooperators in the KALAHY-CIDSS program, where some of its LGUs had been recognized for their innovations like the municipalities of Ubay, Pilar, Buenavista and San Miguel, and the Local Government Unit of Panglao, Bohol as winner of the 2019 PaNata Ko Sa Bayan Awards under the sub-category GAPAS Award: Model LGU Implementing Kalahi-CIDSS;

WHEREAS, with the completion of the National Community-Driven Development Project-Additional Financing (NCDDP-AF) in 2024, the KALAHY-CIDSS NPMO is exploring a follow-on project with focus on improving the adaptability of poor and vulnerable communities to climate change, a shift in its strategy of increasing access to services to building resilience among the population and addressing potential effects of climate change;

WHEREAS, the Provincial Development Council (PDC) of the Province of Bohol is responsible for assessing programs, projects and activities (PPAs) as to their alignment to the PGBh Governance Roadmap, Provincial Development and Physical Framework Plan (PDPFP) and the Comprehensive Land Use Plans (CLUPs) and Comprehensive Development Plans (CDPs) of concerned component local government units (LGUs), and finds that the Panahon ng Pagkilos: Community-Driven Climate Action is substantially congruent and complementary to these plans;

WHEREAS, the Province of Bohol is one of the proposed recipient-provinces identified for the Panahon ng Pagkilos, a program grant by the World Bank, that will be implemented by the Department of Social Welfare and Development;

WHEREAS, the proposed sub-projects under the Panahon ng Pagkilos is considered to benefit the Boholanos, especially poor and vulnerable communities, through the integration of vulnerability reduction criteria and resiliency into project structure designs, for better and climate change-adaptive communities.


WHEREFORE, be it resolve as it hereby resolved to **favorably endorse the proposed projects for the Province of Bohol under the Panahon ng Pagkilos: Community-Driven Climate Action of the World Bank (WB)-Department of Social Welfare and Development (DSWD) to the Central Visayas Regional Development Council (RDC-7) for support and further endorsement to the National Economic Development Authority.**
