## PDC EXECUTIVE COMMITTEE RESOLUTION NO. 46-2024

A RESOLUTION FAVORABLY ENDORSING THE PROPOSED AMBULATORY SURGICAL CLINIC IN THE MUNICIPALITY OF LOAY, BOHOL AS ONE OF THE PROJECTS FOR THE BAGONG URGENT CARE AND AMBULATORY SYSTEM (BUCAS) PROGRAM OF THE DEPARTMENT OF HEALTH (DOH) FOR INCLUSION IN THE HEALTH SYSTEM RESILIENCY PROJECT (HSRP) OF THE WORLD BANK (WB) TO THE CENTRAL VISAYAS REGIONAL DEVELOPMENT COUNCIL (RDC-7) FOR SUPPORT AND FURTHER ENDORSEMENT TO THE NATIONAL ECONOMIC DEVELOPMENT AUTHORITY (NEDA)

WHEREAS, Republic Act No. 11223 institutionalizes Universal Health Care for all Filipinos, prescribing reform in the Health Care System in the country and declaring that it is the policy of the State to protect and promote the right to health of all Filipinos and instill health consciousness among them;

WHEREAS, The Province of Bohol, after compliance to the requirements prescribed under RA No. 11223, has been validated by the Central Visayas Department of Health Regional Office (DOH-7) to be at the Functional Level of the Universal Health Care implementation with a validated rating of 94%;

WHEREAS, the World Bank is to fund the Responsive, Equitable, Accessible, Connected, Holistic Universal Health Care (REACH UHC), which will be implemented by the Department of Health (DOH) under the program Health System Resiliency Project (HSRP);

WHEREAS, the Provincial Development Council (PDC) of the Province of Bohol is responsible for assessing programs, projects and activities (PPAs) as to their alignment to the PGBh Governance Roadmap, Provincial Development and Physical Framework Plan (PDPFP) and the Comprehensive Land Use Plans (CLUPs) and Comprehensive Development Plans (CDPs) of concerned component local government units (LGUs), and finds that the HRSP is substantially congruent and complementary to these plans;

WHEREAS, the Province of Bohol is one of the 28 provinces of the Philippines to be included in the Bagong Urgent Care and Ambulatory System (BUCAS), a network of 28 National Ambulatory and Urgent Care Facilities (NAUC Facilities) of the DOH by 2028 with the intention of addressing the primary care needs of the 28 million poorest Filipinos or the "28 for 28 by 28";

WHEREAS, the Provincial Health Office (PHO), presented to the members of the Bohol Provincial Development Council (PDC) the proposal to include the establishment of an ambulatory surgical clinic in the Municipality of Loay, Bohol, which will be among the 28 proposed BUCAS centers in the country, and is proposed to be included in the Health System Resiliency Project (HSRP) funded by the World Bank, with a total project cost of Php83,739,000.00;

WHEREAS, the Provincial Development Council (PDC) of the Province of Bohol is responsible for assessing programs, projects and activities (PPAs) as to their alignment to the PGBh Governance Roadmap, Provincial Development and Physical Framework Plan (PDPFP) and the Comprehensive Land Use Plans (CLUPs) and Comprehensive Development Plans (CDPs) of concerned component local government units (LGUs), and finds that the establishment of an Ambulatory Surgical Clinic in the Municipality of Loay, Bohol under the BUCAS program of DOH to be included in the HSRP of the WB is substantially congruent and complementary to these plans;

WHEREFORE, be it resolve as it hereby resolved to favorably endorse the proposed Ambulatory Surgical Clinic in the Municipality of Loay, Bohol as one of the projects for the Bagong Urgent Care and Ambulatory System (BUCAS) program of the Department of Health (DOH) for inclusion in the Health System Resiliency Project (HSRP) of the World Bank (WB) to the Central Visayas Regional Development Council (RDC-7) for support and further endorsement to the National Economic Development Authority (NEDA)

Resolved further, that copy of this resolution be furnished to the Office of Congresswoman Kristie Alexie B. Tutor of the Third Congressional District of Bohol, for her support and appropriate action.
