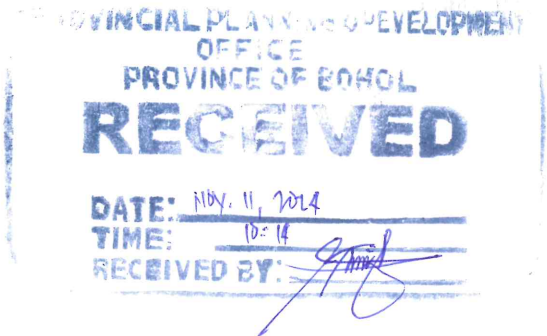



### PDC EXECOM RESOLUTION NO. 66 - 2024

**A RESOLUTION FAVORABLY ENDORSING THE PROPOSED ROAD CONCRETING PROJECT OF THE SIKATUNA - SEVILLA VIA LOBGOB ROAD TO THE SANGGUNIANG PANLALAWIGAN OF BOHOL FOR THE ALLOCATION OF FUND IN THE PROPOSED SUPPLEMENTAL INVESTMENT PROGRAM NO. 6 FOR CY 2024**

**WHEREAS**, the Sikatuna-Sevilla via Lobgob Road is an existing provincial road with 6.40 kilometers paved and 3.10 kilometers unpaved with the total length of 9.50 kilometers;

**WHEREAS**, the said road is connected to the Tagbilaran City-Corella-Sikatuna Road (TCCSR) which is a national road and is a shorter route going to Tagbilaran City at about 28 kilometers than the Sevilla-Tagbilaran via Quinoguitan - (Loay-Interior Road) which is about 33.5 kilometers;

**WHEREAS**, this road is a vital access route during calamities and plays a pivotal role in fostering economic development and well-being of constituents by improving connectivity, accessibility, and opportunities for growth;

**WHEREAS**, the remaining 3.10 kilometers unpaved section will cost in the amount of 105,000,000.00 to upgrade, with allocation of 40,000,000.00 from the Capital Outlay of Local Disaster Risk Reduction and Management Fund (LDRRMF) of the Provincial Government of Bohol (PGBh);

**WHEREAS**, the road concreting of the said road will be a viable economic option, consistent with the strategies of the Bohol Spatial Development Framework of improving the transport interconnectivity and fully supportive of the development thrusts of the National Government as well as the Provincial Government of Bohol and its Strategic Governance Roadmap;

**WHEREAS**, the proposed concreting project will directly benefit the Province of Bohol and its people, particularly in providing accessibility of the

travelling public through unhampered, safe and secure alternative primary road within the province;

**WHEREAS**, this Body, after deliberation, has found that the proposed road concreting of Sikatuna - Sevilla via Lobgob Road is a strategic program that will improve the linkages within the province, which is an essential element in the sustainable development of Bohol, thus worthy of support and favorable endorsement to the Sangguniang Panlalawigan for support;

**WHEREFORE**, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened -


